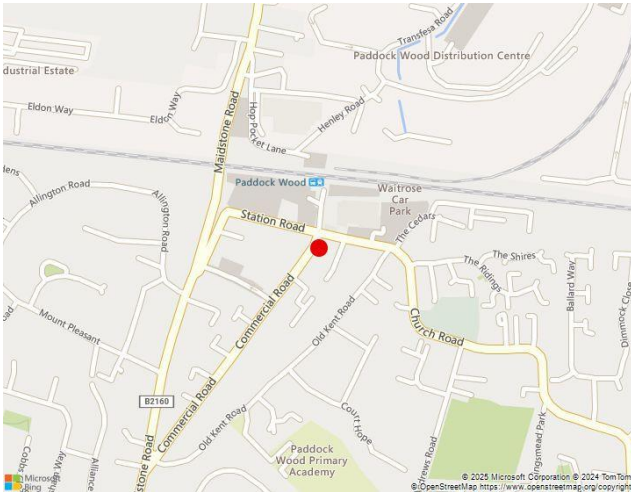

Location

Paddock Wood Business Centre is situated in a prominent position at the north end of Commercial Road, directly opposite Paddock Wood Mainline Station which provides frequent rail services to London Charing Cross via Tonbridge in approx. 50 minutes. The property is surrounded by local amenities including a Waitrose supermarket as well as a variety of independent and national retailers.

Paddock Wood has excellent connectivity being 6.5 miles East of Tonbridge, 7 miles South West of Tonbridge Wells and 14 miles South East of Sevenoaks.

Accommodation

Paddock Wood Business Centre is a mixed use building comprising retail units on the ground floor and 5 office suites across the 1st and 2nd floors. The building is currently fully let, with Suite 4 becoming available towards the end of February 2025.

Suite 4 is located on the 2nd floor and provides largely open plan office space with 5 partitioned cellular rooms, two WCs and a kitchen. The suite also benefits from air conditioning throughout and lift access.
