Mount Road Trading Estate is situated on Mount Road which is a mixed industrial and residential area approximately 2 miles north of Brownhills and 5 miles east of Cannock. The A5 Watling Street is approximately 1.5 miles distant leading to the M6 Toll Road Churchbridge Interchange junction T7.

### DESCRIPTION

The estate comprises of 11 units being of steel framed construction with brick elevations and lined corrugated roofs. The minimum eaves height is approximately 10ft (3.035m) and the unit has an office and WC facilities.

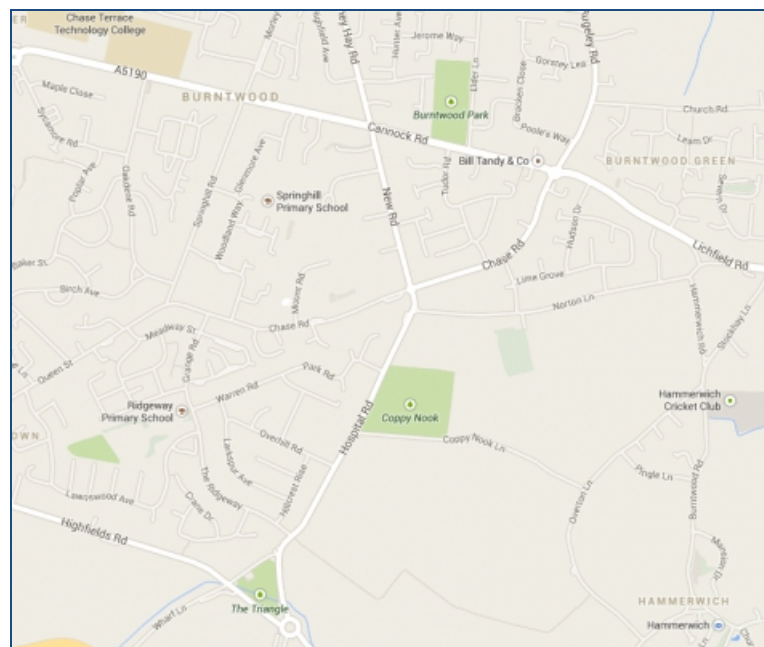
