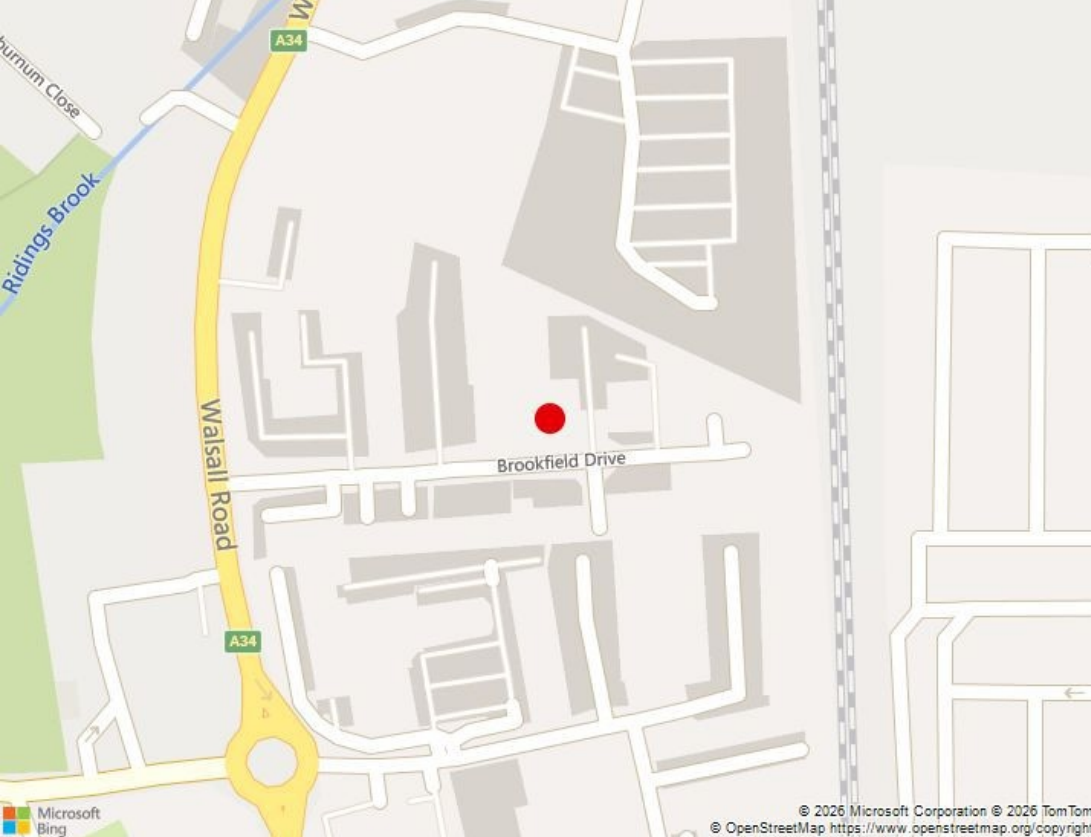

LOCATION

The property is situated on the southern side of Brookfield Drive close to the corner of a cul-de-sac position, with nearby access to Walsall Road (A34) which in turn provides links to the M6 Toll Road at the Churchbridge interchange junction. The A5 trunk road is situated approximately a 1/4 mile distant and junctions 11 and 12 of the M6 motorway are approximately 2 and 2.5 miles away respectively.

DESCRIPTION

The premises are located to the ground floor and provide predominantly open plan accommodation being accessed via a ground floor lobby/reception and offers an open plan office together with partitioned meeting rooms/offices along with separate modern male and female and disabled WCs. The offices benefit from a large kitchen/canteen area with two further partitioned rooms currently used as a server room and storeroom. The specification includes carpeting, suspended ceilings, LED lighting and air conditioning. There is a car park to the front and side of the building.
