DESCRIPTION

A development of 3 brand new industrial units located on the Shepherds Grove Industrial Estate. The Industrial Estate is located in the village of Stanton off the Bury Road (A143) and the units are located at the front of the Industrial Estate on the corner of Grove Lane and Upthorpe Road.

The new units are built to a shell and comprise of a steel portal frame with insulated plasticised steel roof and cladding with a tarmacadam forecourt and parking area.

Mains electric, water and foul drainage connection are in place.
