Location

Unit 1.10 is situated on the Arches Industrial Estate which is accessed from the B4101 Spon End, adjacent to the landmark Spon End viaduct where it crosses the River Sherbourne.

The Estate is situated close to the Coventry City Centre ring road giving access to Junction 7 from the west side of the City Centre.

Specifically the unit is located to the rear of the Estate and up the short ramp to the left.

Description

Unit 1.10 provides a mid-terrace brick built industrial premises primarily over a single floor.

Internally the unit benefits from a partitioned rear office, WC facilities, inset LED lighting, three phase power and mains gas. Additionally there is a generous eaves height (4.5 m) and additional storage mezzanine to the rear. Access to the property is by way of a roller shutter and additional personnel entrance.

Externally, there are two parking spaces to the front of the unit. Additional parking/compounds can be let by way of separate agreement.

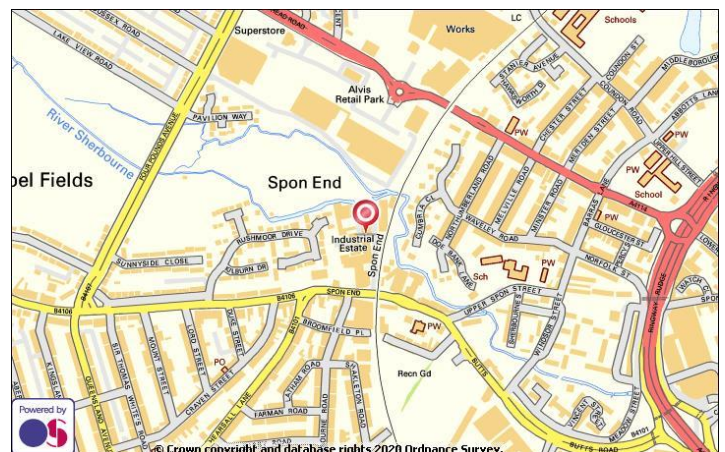
