LOCATION

Lewes is the county town of East Sussex, nestled within the South Downs National Park, with a direct fast train service to London. The town offers an excellent range of shops including two prime supermarkets, Waitrose and Tesco, along with a variety of independent medieval and Georgian high street shops. Additionally, Lewes offers a wide range of popular cafés, old inns, and restaurants as well as a farmers' market held on the first and third Saturdays of every month. Timbryard Lane leads down to the River Ouse from South Street.

DESCRIPTION

This rectangular and level site fronts Timbryard Lane whilst backing onto Morris Road and is accessed via wooden gates through the external flint walls. Its approximate dimensions are 20m x 12m.

The site lends itself to various leisure or commercial uses (STP) or redevelopment. See below for information on the consented scheme. Timbryard Lane has been subject to several redevelopment schemes, including Chandlers Wharf and the new homes either side of the site.

PLANNING

The site has been subject to several applications. The most recent was consented on 17/09/2025 under application **SDNP/24/01995/FUL**. This consent provides for a townhouse on each side of the site, each with a garden and integral garage. See floor plans overleaf.

Each townhouse extends to **115 sq.m & 135 sq.m** respectively.

Alternative schemes may be possible for 1 larger house on one side (STP).

Buyers should note that the site has utility services running beneath, which may require re-routing. Further information upon request.

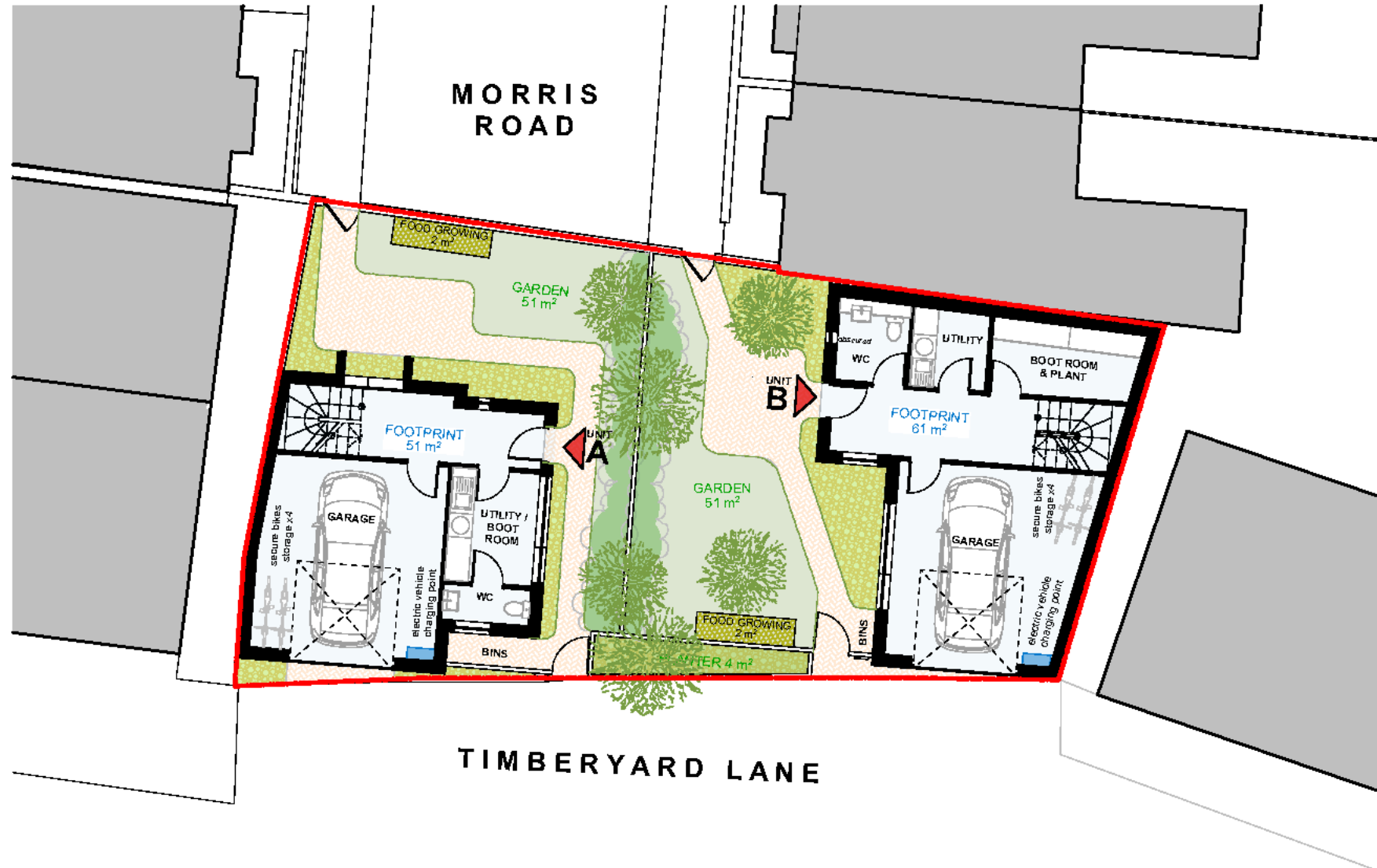

Proposed Ground Floor Plan

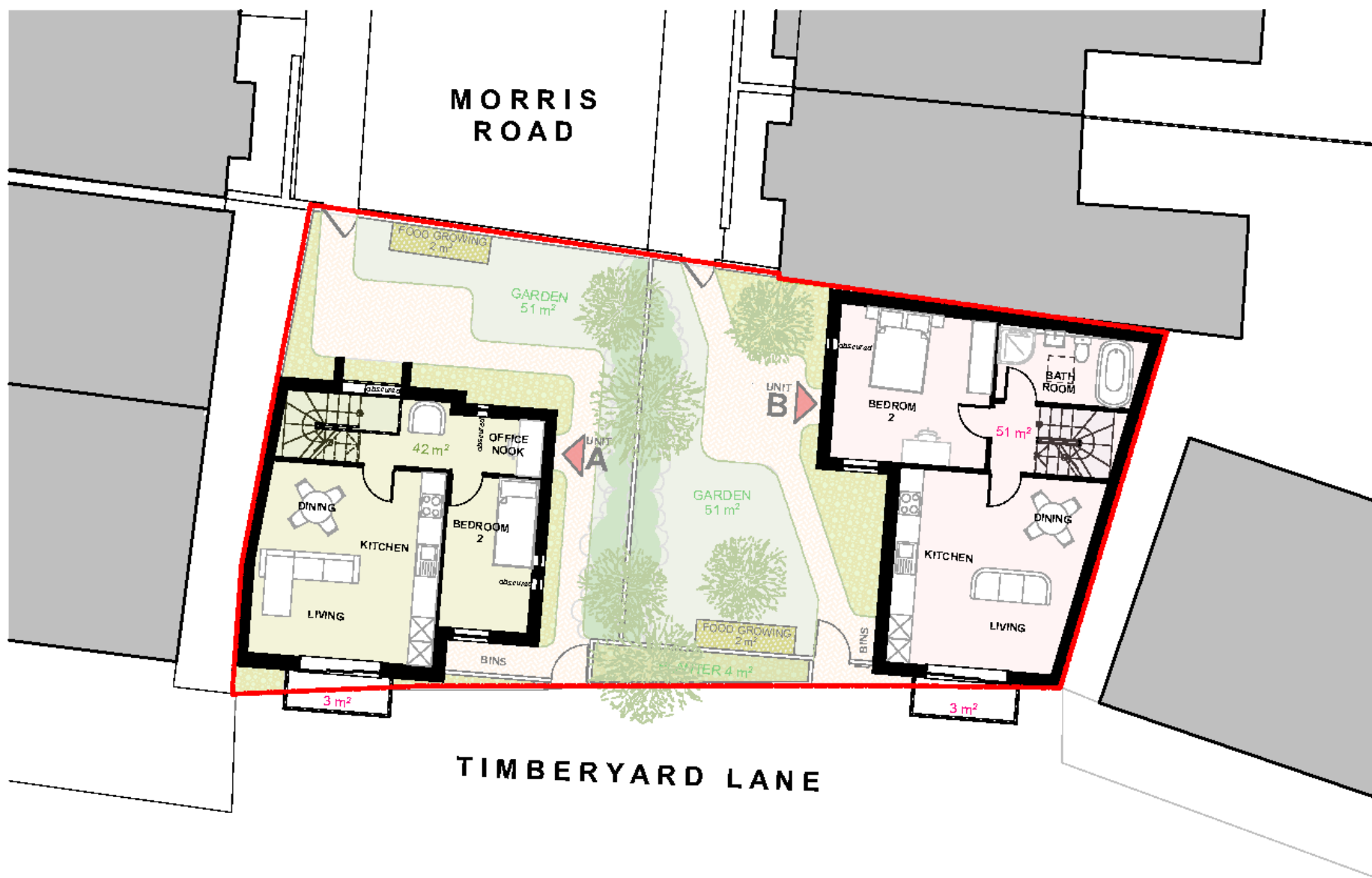

Proposed First Floor Plan

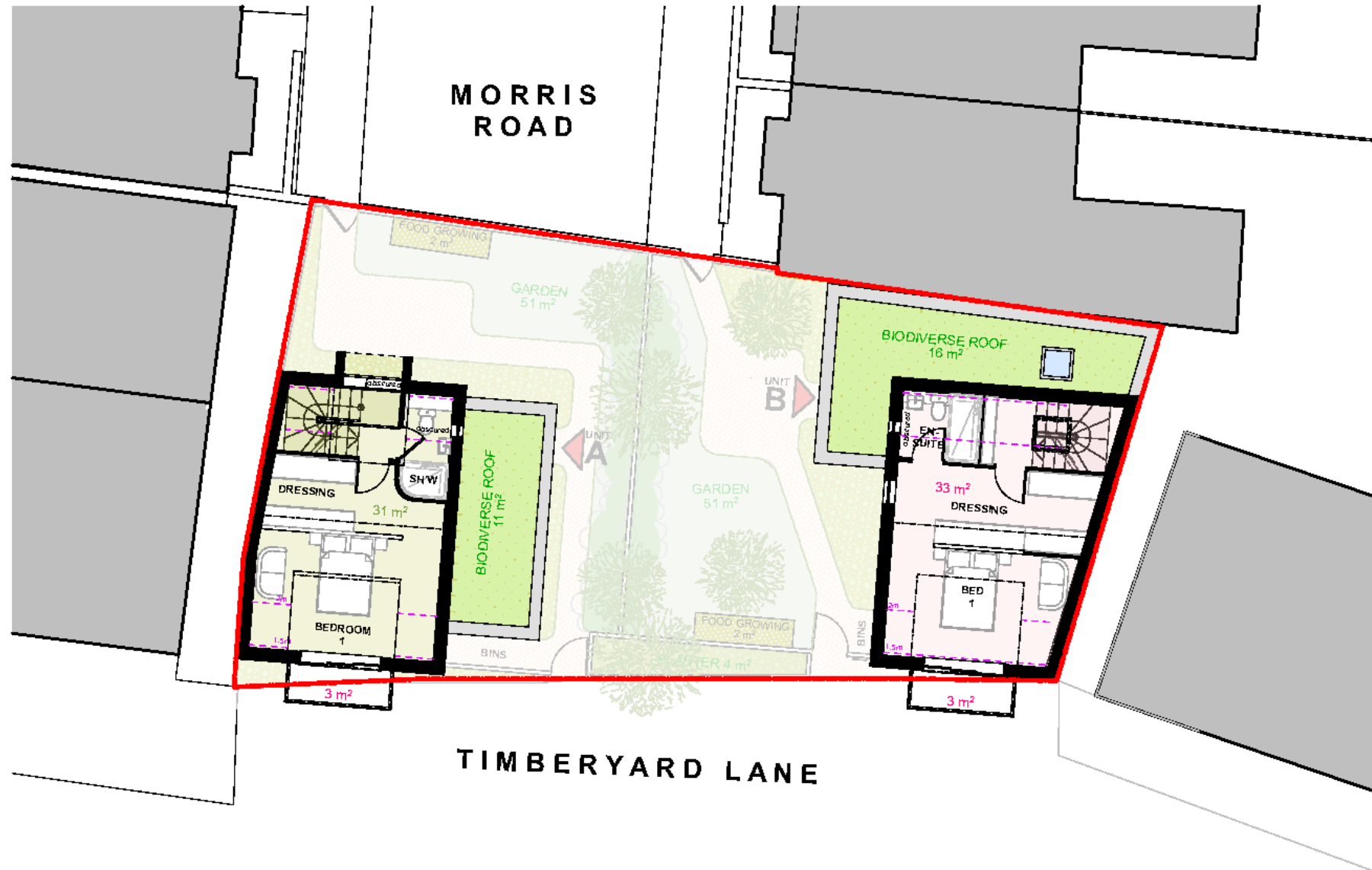

Proposed Second Floor Plan

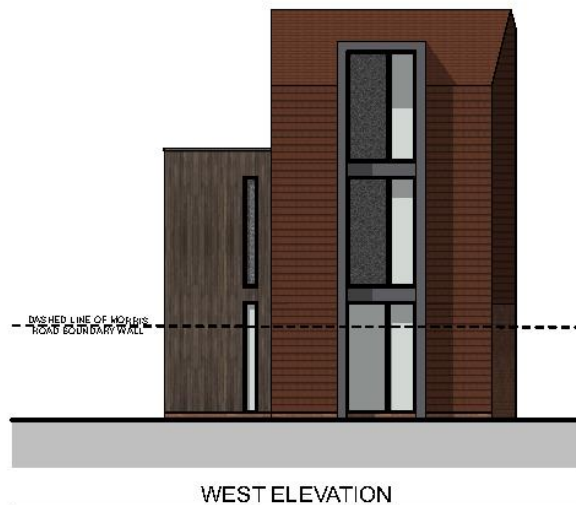

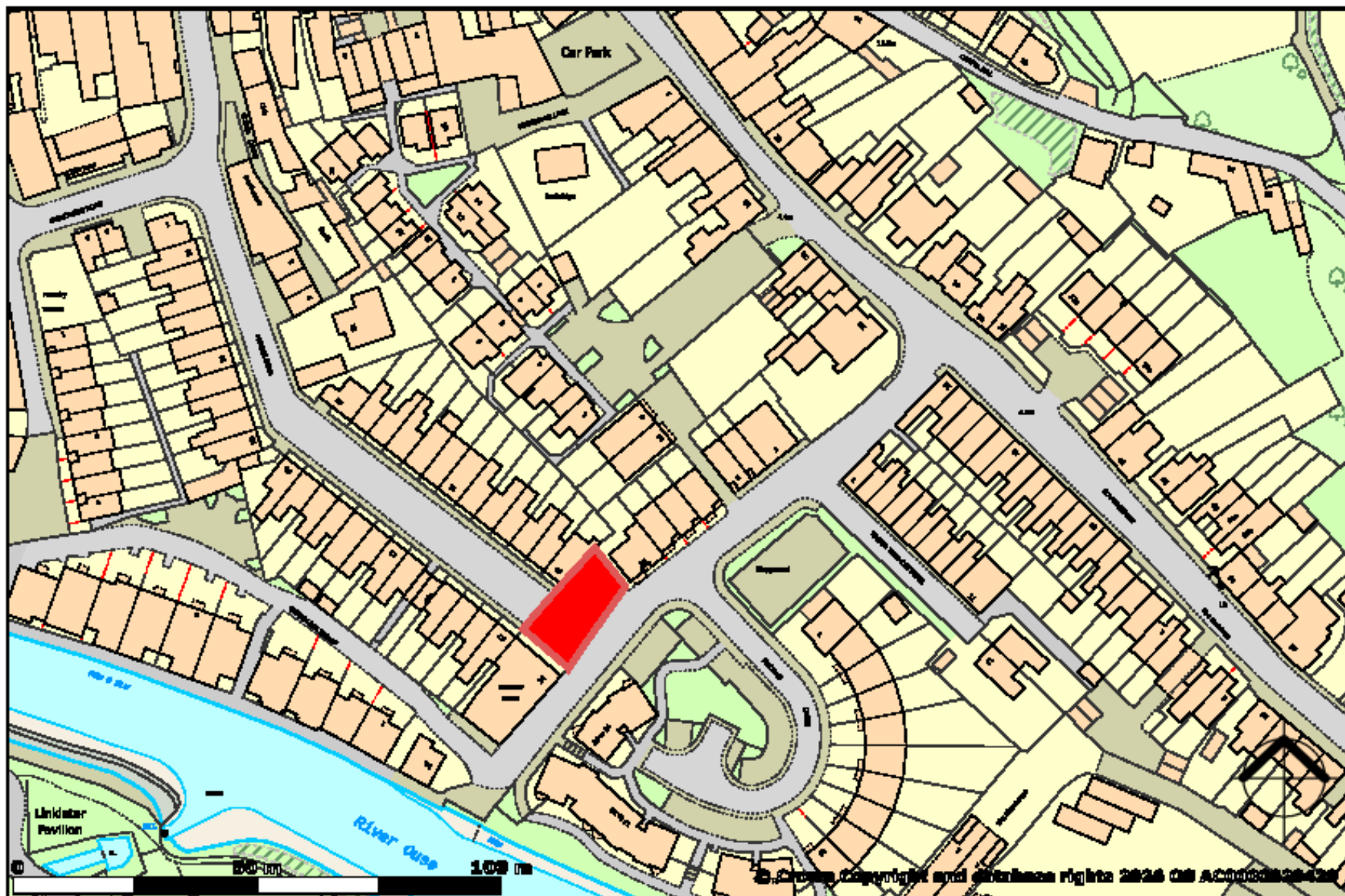
Proposed Unit B Elevations
