LOCATION

Shirebrook is in the Bolsover district of Derbyshire, approximately 5.6 miles north of Mansfield and 11 miles east of Chesterfield.

The Tangent Business Hub is located 0.6 miles south east of Shirebrook Town Centre and accessed via Weighbridge Road. It is a predominantly commercial location with nearby occupiers to include the Sports Direct Distribution Centre, Evans Cycles and Flannels. A good range of amenities to include an Aldi, High Street shops, restaurants and professional services are located in the nearby Shirebrook town centre.

Good public transport links are close by. There is a bus stop within walking distance and Shirebrook train station is just 0.9 miles (1.4 km) to the north.

Commuter links are provided by the A617 which connects with J29 of the M1 7 miles to the west and with Mansfield to the east.

DESCRIPTION

Creative studio office space in prestigious business centre with manned reception. Excellent Parking. Finished with tea point, underfloor heating, perimeter trunking, LED lighting, telecoms, high speed internet (2mbps guaranteed), CCTV to external and common parts.

The centre benefits from a manned reception (week days), informal meeting & breakout space, bookable conference rooms, showers and fully fitted kitchens. Externally there is a barrier controlled car park providing 120 spaces operated on a first come first serve basis.

The studio/workshop does not have loading doors so are suited to light assembly and creative industries.

PLANNING

SERVICES

The suites are offered on an "inclusive" rental basis. Rent includes a contribution towards the cost of a meet and greet reception, security, CCTV, water in shared WC's, kitchens and showers, repairs/maintenance of common and external areas, underfloor heating and car parking.

Each suite benefits from a sub metered electricity and water supply with the tenant being recharged. A telephone line and one handset is included in the rent, additional handsets are available at £3.50 plus vat per handset per month. Wifi can be activated for a one off charge of £40+VAT.

Tenants are responsible for payment of any business rates (if applicable).

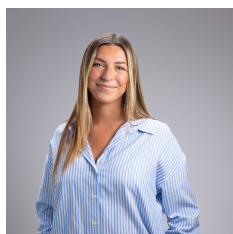

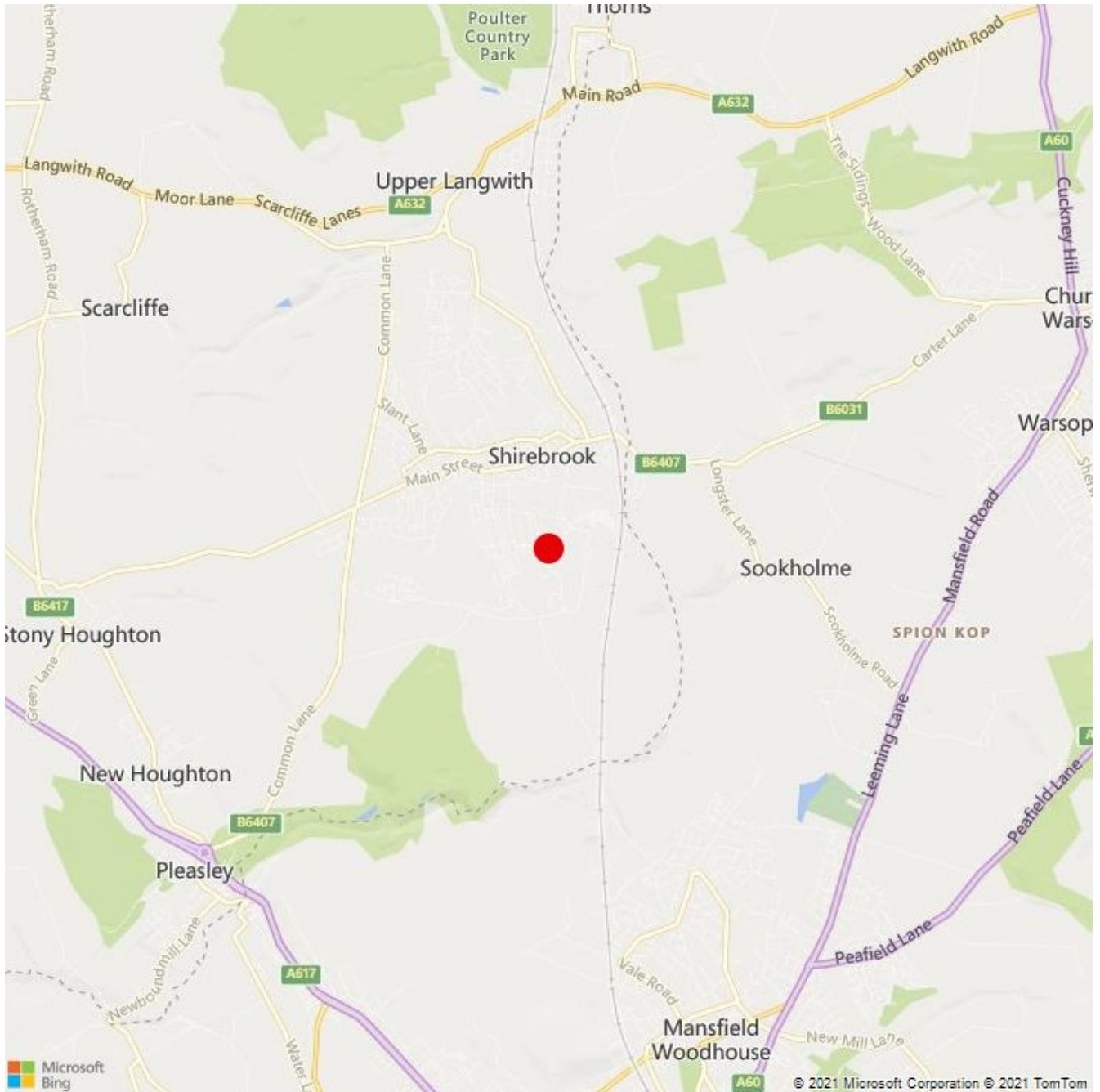
