Direct access to the M5 Junction 4 (2 miles), M42 Junction 2 via B4120 (3 miles) and just 9 miles from Birmingham City Centre within the Central Technology Belt. Parklands Business Park is in close proximity to Longbridge Train Station (1 mile), providing regular direct access to Birmingham City Centre.

Six regular bus services run at least every ten minutes during the week from the A38 to Longbridge train station and beyond.

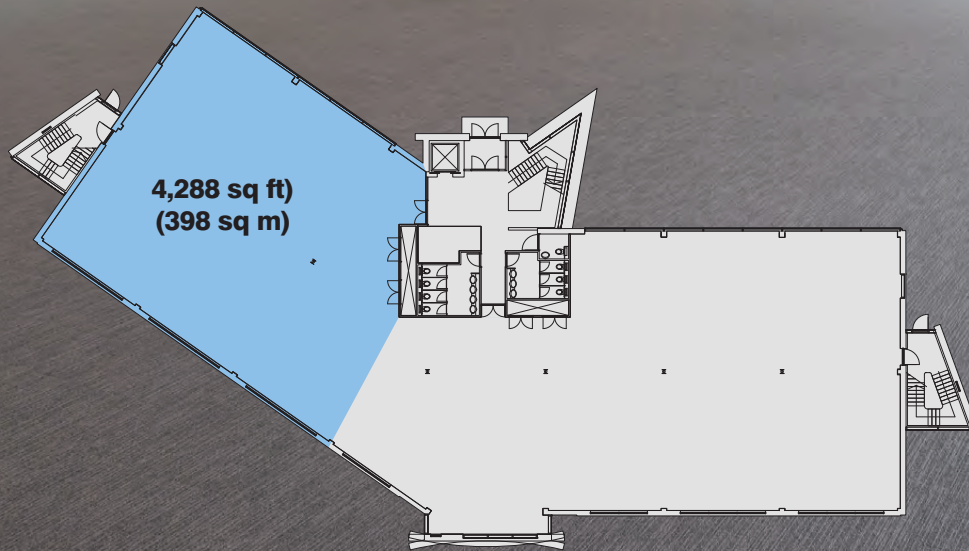

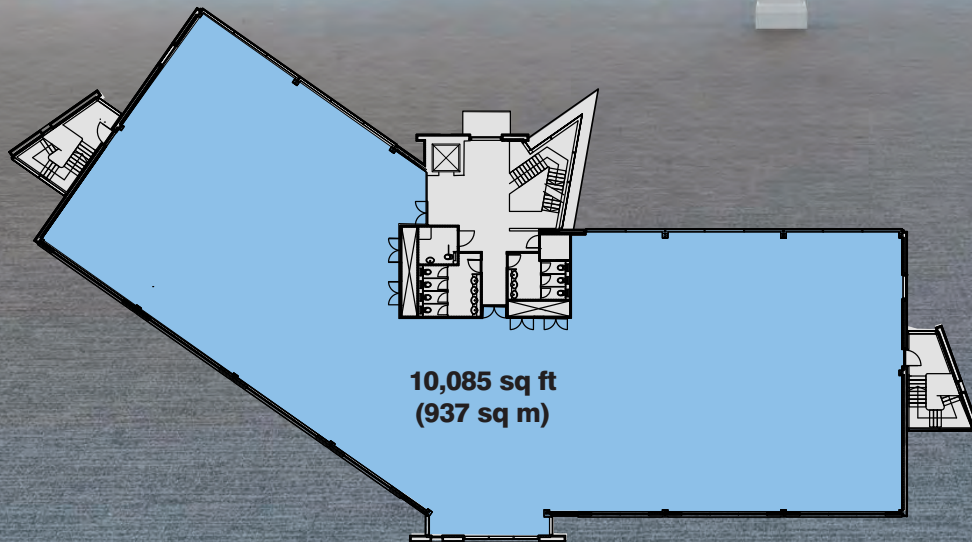

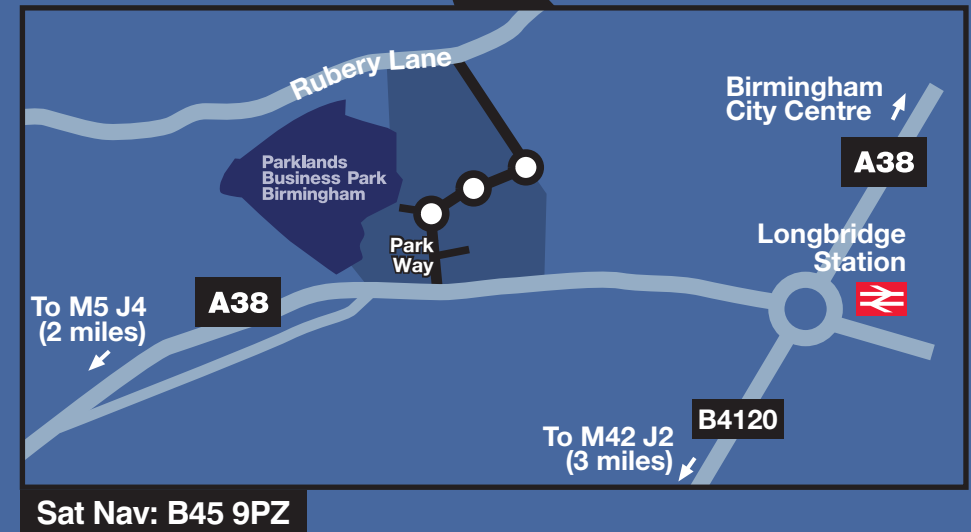


Second Floor Available July 2026
