



4 Burns Statue Arcade, Ayr, KA7 1SW

The subjects comprise a ground floor mid-terraced retail unit contained within a two-storey building of brick construction roughcast rendered externally beneath a pitched, hipped and slated roof. There is residential accommodation above the subjects, which is in separate ownership and excluded from the subject property.

Access to the property is provided by a shallow stepped entrance from pavement level via a single pedestrian doorway from a full height glass aluminium-framed shop frontage.

Internally, the accommodation is fully fitted as a hair salon and has a solid concrete floor, plasterboard walls with Artex finish and suspended grid-style ceiling with recessed lighting. Whilst currently fitted as a hair salon, the property provides flexible retail accommodation of an open plan nature with staff kitchen and single WC, which would be suitable for a number of retail uses.

Common access to the rear of the property is provided by a rear doorway.



LOCATION

Ayr is the administrative centre of the South Ayrshire Council area and is located on the west coast of Scotland on the Firth of Clyde. Ayr is situated approximately 14 miles south-west of Kilmarnock and 35 miles south-west of Glasgow. Ayr has a resident population of approximately 46,489 persons (Census 2022).

The subjects are located on the west side of Burns Statue Arcade, between the junction of Burns Statue Square to the south and Kyle Street to the north.
