## LOCATION

This property is located in the established Earlstrees Industrial area of Corby and accessed off Brunel Road. Corby is situated 10 miles north of Kettering, 11 miles east of Market Harborough, 8 miles south of Uppingham and 12 miles west of Oundle.

## DESCRIPTION

The property comprises a mid terrace industrial unit accessed via roller shutter door and personnel entrance. The unit is mainly open space with male and female w.c's. A mezzanine floor has been installed to part providing offices and kitchen.

## ACCOMMODATION

The premises have been measured in accordance with the RICS code of measuring practice on a gross internal floor area basis.
