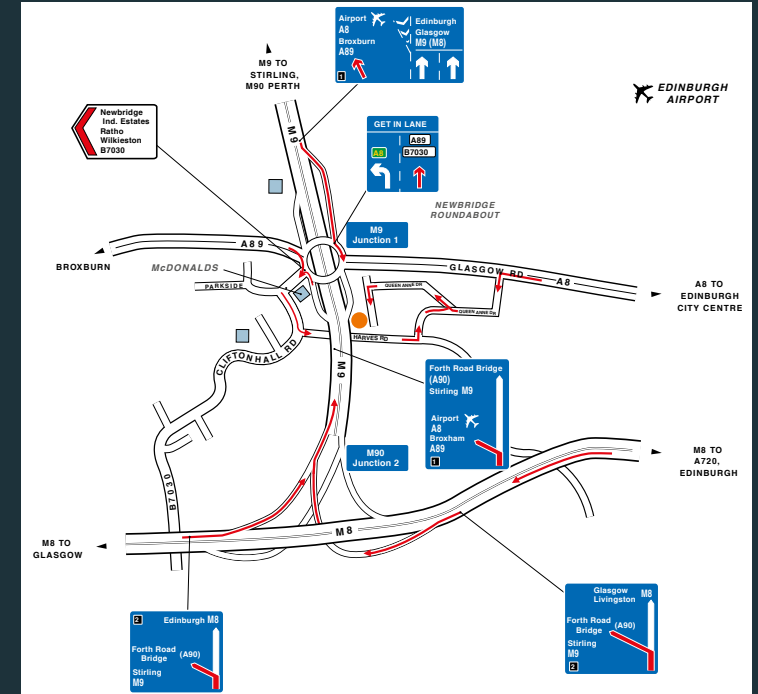


## Location

Newbridge is East Central Scotland's prime industrial distribution location, situated adjacent to the Newbridge Interchange approximately 8 miles west of Edinburgh city centre.

Queen Anne Park is situated within Lochend Industrial Estate, located immediately to the south-east of Newbridge Interchange. The estate lies immediately east of the M9 with access provided via Queen Anne Drive, which in turn connects to Harvest Drive. The location of Newbridge allows direct access to 90% of the Scottish population within a 2 hour drive.

Nearby occupiers include Geopost, Scotmid, Broxburn Brown, Fedex, DHL, Greggs, National Galleries of Scotland, Travelodge, APC and NHS.



## Description

Queen Anne Park consists of an industrial estate providing two terraces of modern industrial units constructed circa 1995. Units 1&2 are occupied by APC Parcels, Unit 3 by NHS Scotland and Unit 5 by National Galleries of Scotland.

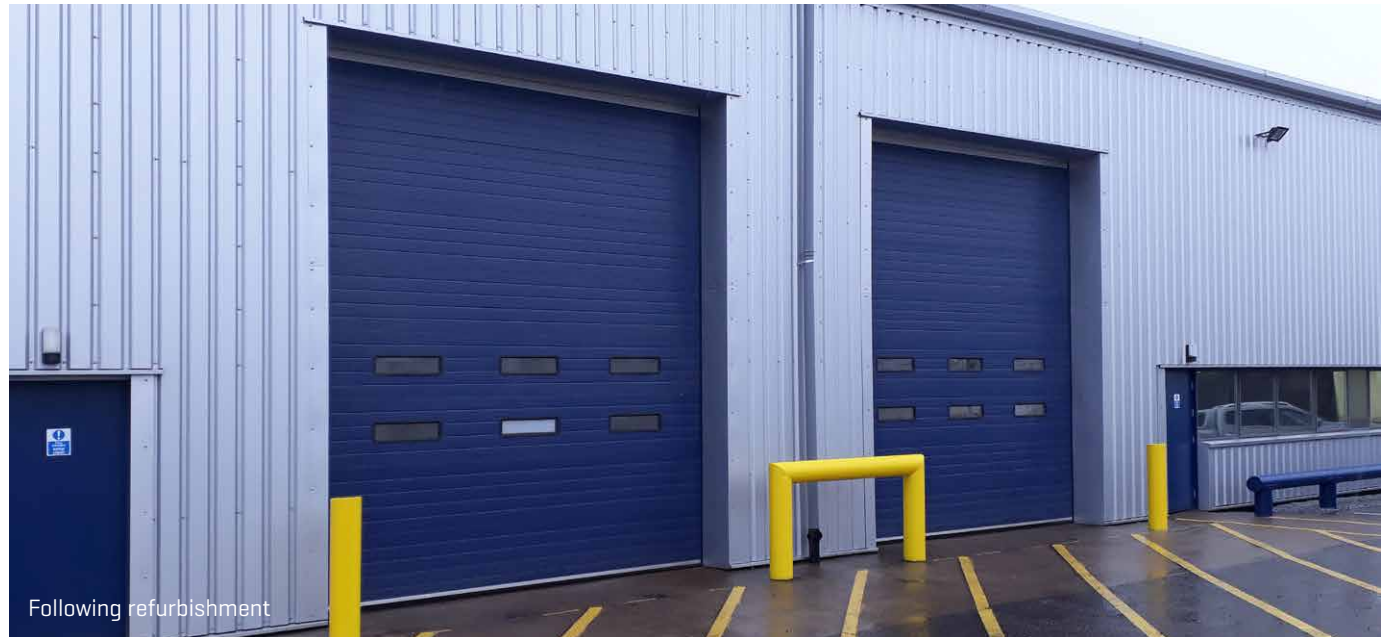
The buildings are of portal steel frame construction, with an eaves height of 6m. External walls and roofs are clad in insulated steel cladding, incorporating Perspex roof lights. There are double-glazed metal framed windows along the front elevation. Each unit has an electrically operated up and over roller shutter access door. Internally, there are block dado walls with a full height division walling incorporating knock out panels.

Refurbishment due to be completed mid 2021.

## Service Charge

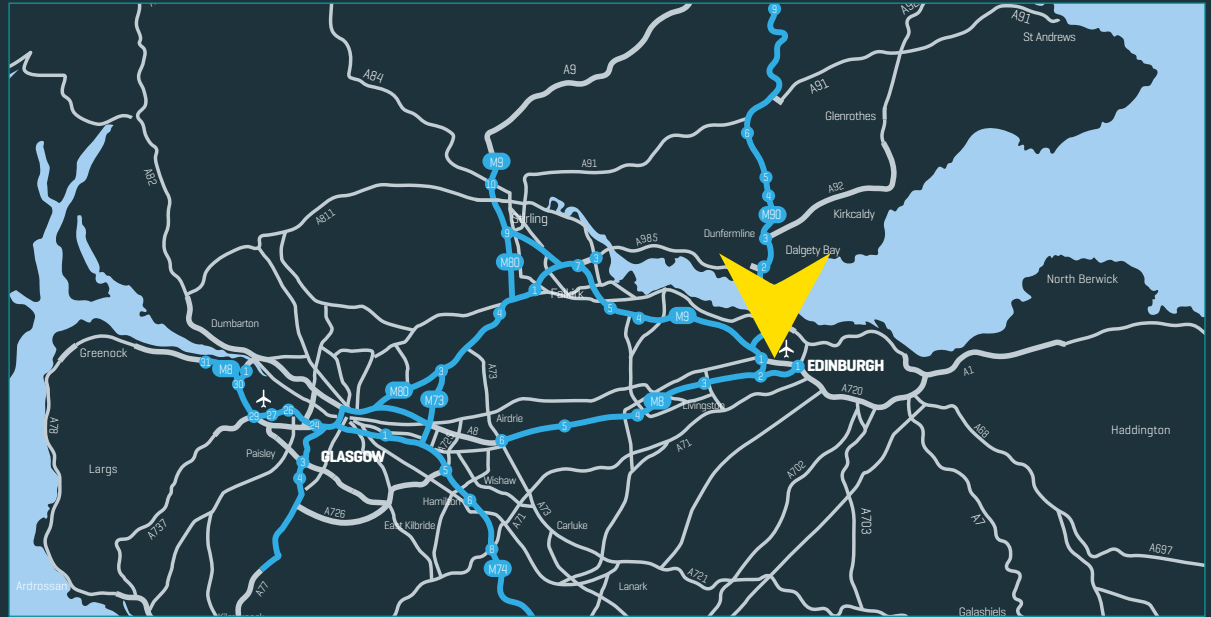
A service charge for the common maintenance and management of the estate will be payable.
