Location

The subject is located in the heart of the Merchant City, between Hutcheson Street and Brunswick Street. In close proximity to George Square and other local amenities.

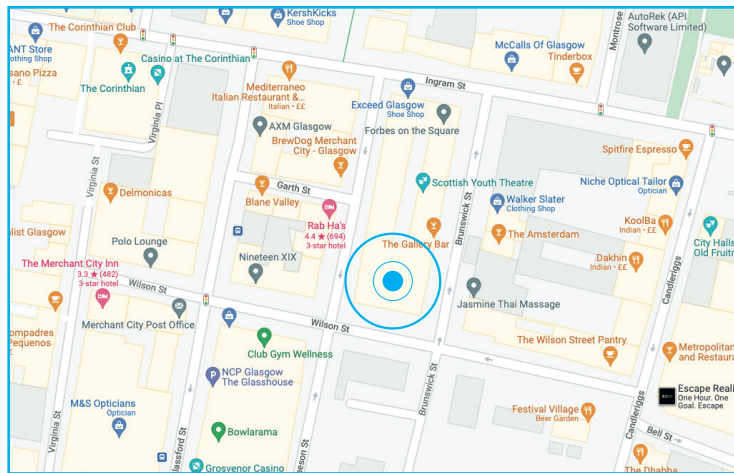
The property has strong public transport links being 5 minutes' walk from Queen Street Station and 10 minute walk from Central. In addition to bus links and the subway.

Description

The Old sheriff Court is an impressive listed building converted in 2005 into a mixed use residential/commercial development.

The suite is an open plan layout with a central core in a fully refurbished condition. Benefiting from raised access flooring, suspended ceiling, Full VRV air conditioning, dedicated toilet and shower facilities and wheel chair access.

The second floor office suite is accessed by the ground level secure lobby from Hutcheson Street. Access to the upper floor is provided by way of stairs and a DDA compliant lift.
