LOCATION

The property is situated on Magdalen Road being a small neighbourhood shopping parade serving passing traffic but more specifically the immediate catchment area of St Leonards, a highly regarded and high-value residential district of Exeter.

Magdalen Road is located close to the city centre and within easy walking distance of it and it provides a good range of retailers, albeit mostly local or specialist traders. The Parade is generally fully occupied and benefits from a small number of time restricted public car parking spaces. Other occupiers in the vicinity include various independent retailers, bars and professional and financial services.

DESCRIPTION

The property comprises a ground floor lock up shop with main sales, rear storage and staff facilities. There is a self contained maisonette on the first and second floors providing two bedrooms with a kitchen and bathroom. To the rear there is a detached store.

TENANCY
