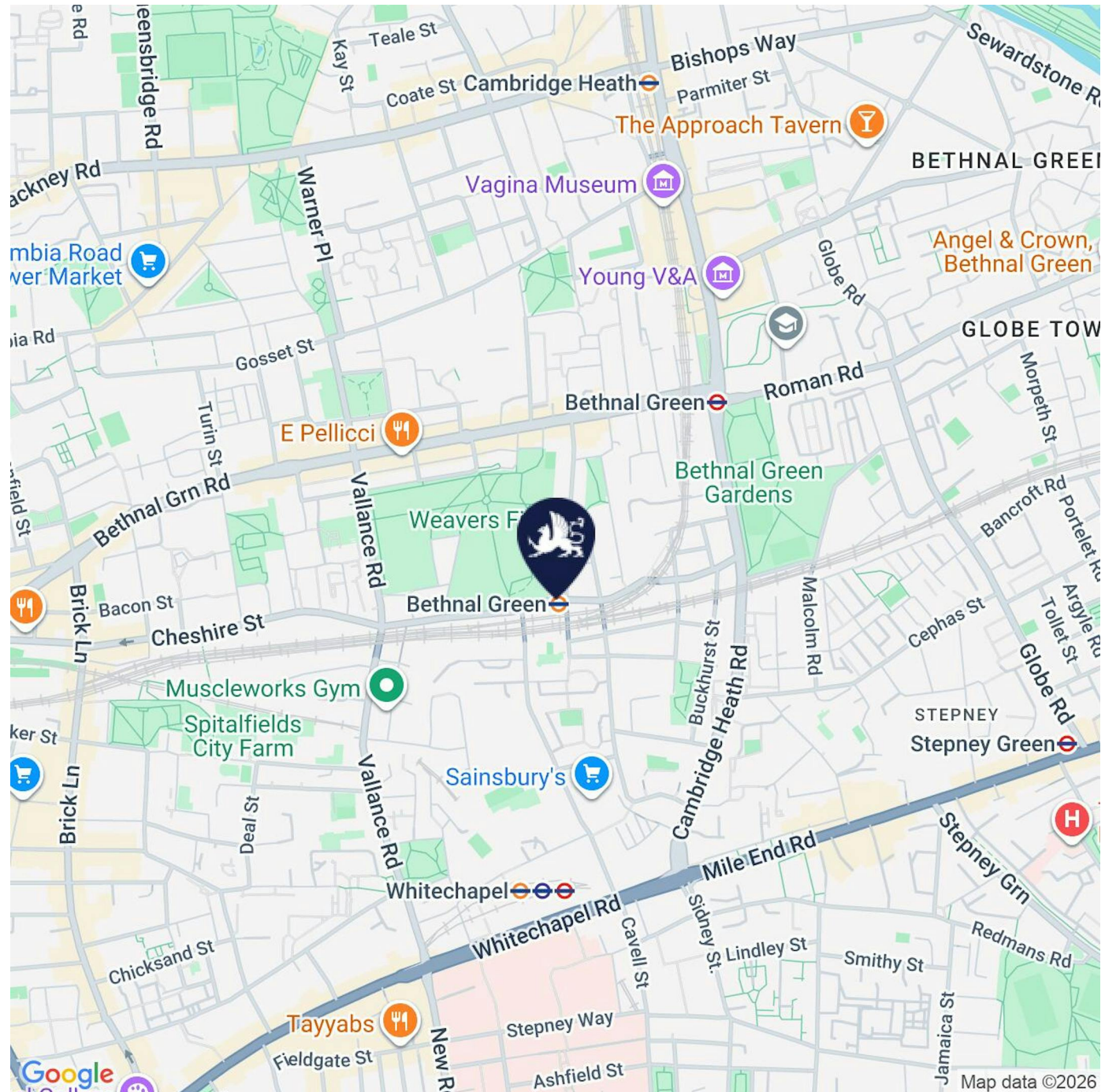


Location
