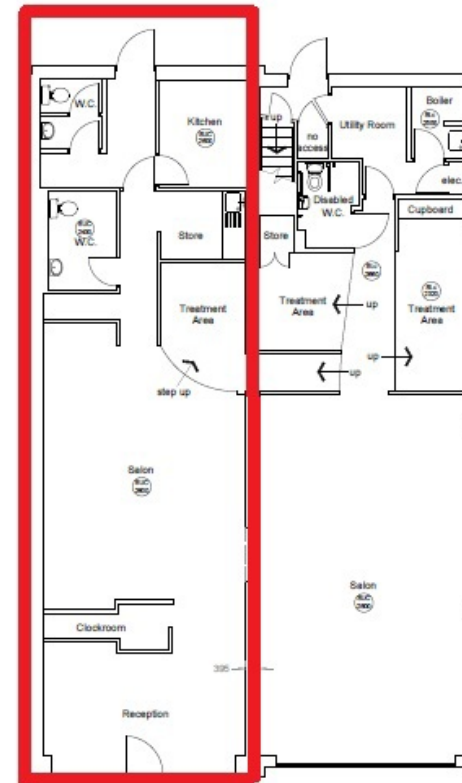

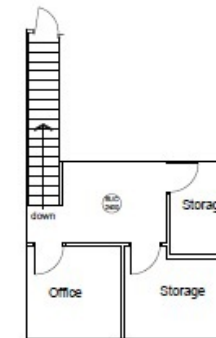
Front Elevation
