Location

Salisbury is a historic Cathedral City in Central Southern England with a resident population of 41,800 approx. and the County's population is 510,300 (Source: 2021 Census). The City and its magnificent Cathedral together with the World Heritage site at Stonehenge, are major tourist attractions for the region. Salisbury has a main-line railway station with frequent service to London Waterloo.

Old Sarum is situated approximately 1.5 miles north of Salisbury alongside the A345 Salisbury to Amesbury Road. The A303 lies approximately 7 miles north at Amesbury.

Description

The property comprises a modern business unit with full height curtain wall glazing to the front elevation, with insulated profile steel cladding to the roof. The building has been fitted out to a high standard to provide ground and first floor office accommodation, mainly open plan. The offices have suspended ceilings with recessed Category II lighting, fitted carpets, central heating and air conditioning. There are high quality fitted kitchens and WC's on ground and first floor and a number of individual offices.

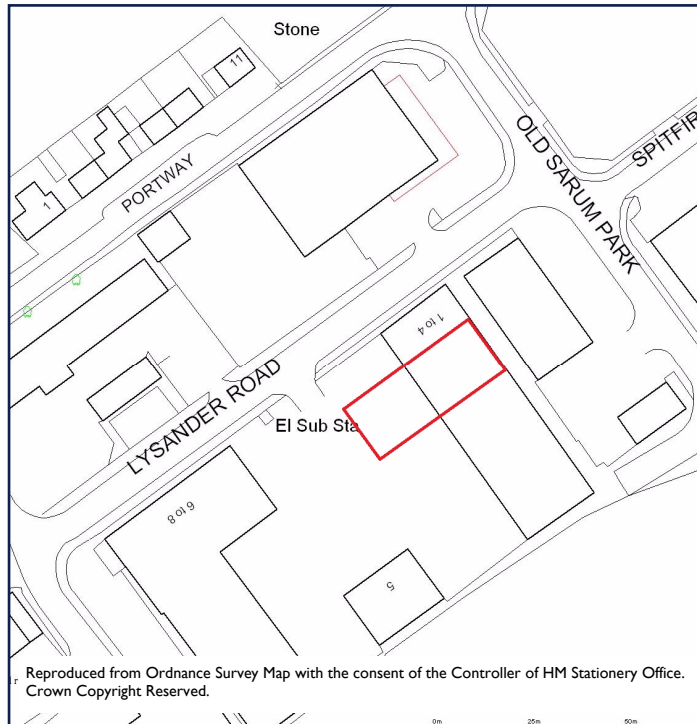
Outside the forecourt provides around 14 car parking spaces.
