DESCRIPTION

The property comprises a self-contained detached warehouse of steel portal frame construction with brick and profile metal cladding to the elevations under a pitch roof incorporating translucent roof light panels.

The property benefits from two storey offices to the front along with a substantial mezzanine providing additional offices and storage. The offices are of brick construction with double glazing, suspended ceilings and offer a mixture of open plan areas and cellular offices with an atrium feature along with kitchen and WC area.

The main warehouse benefits from 5.85m eaves, suspended lighting and full height level access loading doors at the front and side elevation.

LOCATION

Riverside Industrial Estate is located on Riverside Way off Mill Pond Road close to the junction with Home Gardens (Dartford town centre ring road system) close to the town centre. Access to junction 1a M25 is from Victoria Road via Bob Dunn Way (A206). Dartford railway station is a short walk from the estate with regular train services to London Bridge, Charing Cross and Cannon Street.

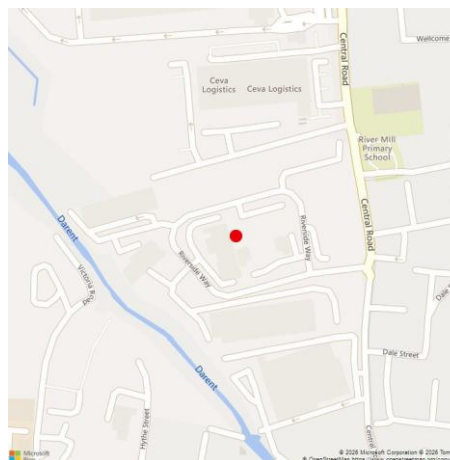
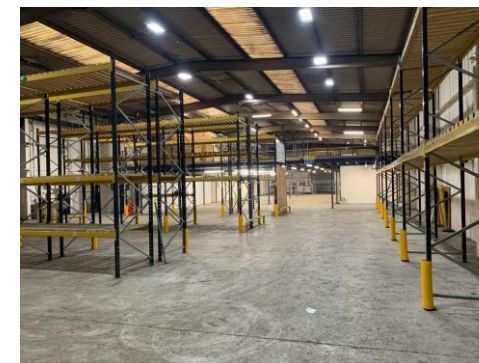
