DESCRIPTION

A modern light industrial/high-tech unit arranged over ground and first floors.

At ground floor level, double doors open into a racked packing/warehouse area with height of 2.4m. The ground floor also includes two WCs (one incorporating a shower), a kitchenette, and a rear office/storage room.

The first floor offices have an open-plan workspace, three meeting rooms, and perimeter trunking with inset Cat V data cabling. The office areas benefit from air conditioning, and as there is no gas supply, heating throughout the property is electric.

The unit is equipped with both intruder and fire alarm systems.

There are 4 parking spaces externally plus additional elsewhere on the estate for visitors.

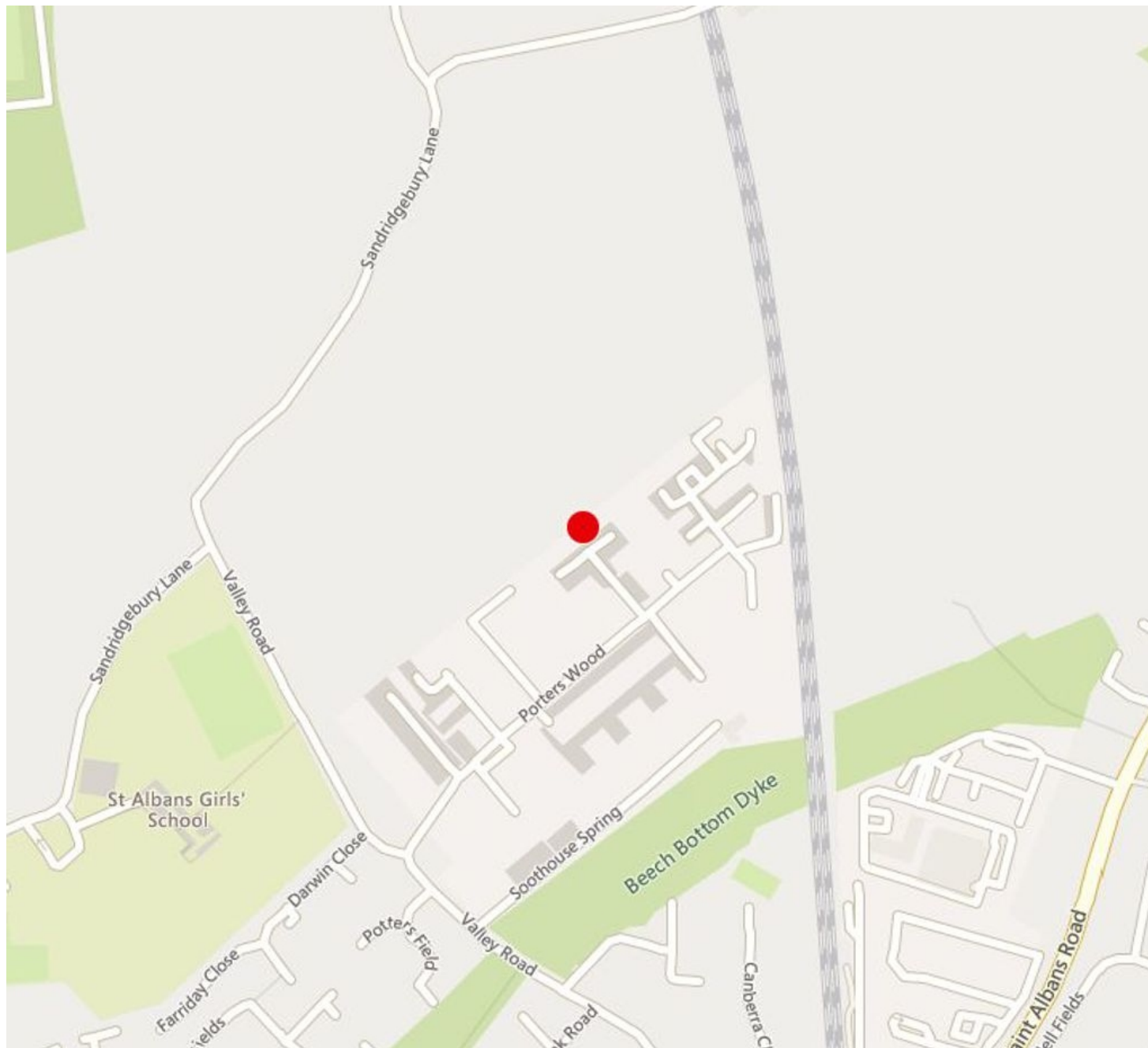
