The accommodation sizes start from 528 sq ft. Overall availability is as follows:-

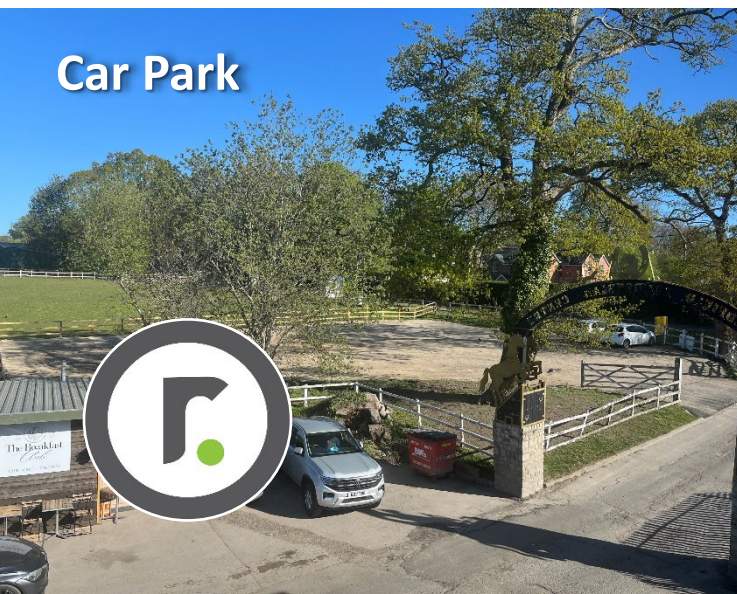
