Description

The property is a modern, three storey building with cladding and glazed elevations and surface parking on an established business park.

The available space comprises the whole of the second floor which provides good quality office accommodation which is capable of being split to suit requirements from 4,000 sq ft. The office space benefits from the previous tenants fit out which includes meeting rooms, private offices, kitchen/break out, data cabling and comms room. This can be retained resulting in a substantial cost saving for the incoming tenant. Alternatively the floor can be reinstated back to open plan accommodation.

Location

Leatherhead is approximately 20 miles south west of central London, the M25 J9 is approximately 1 mile and the A3 4 miles.

The mainline station provides direct services to Waterloo and Victoria approx travel time 50 mins.

The property is situated on a business park approximately 15 minutes walk to the station and 20 minutes to the town centre with all its amenities including The Swan Shopping Centre, restaurants, bars, coffee shops, gyms and Travelodge.

The property is available to let on a new lease. Flexible terms and inclusive rents can be agreed.

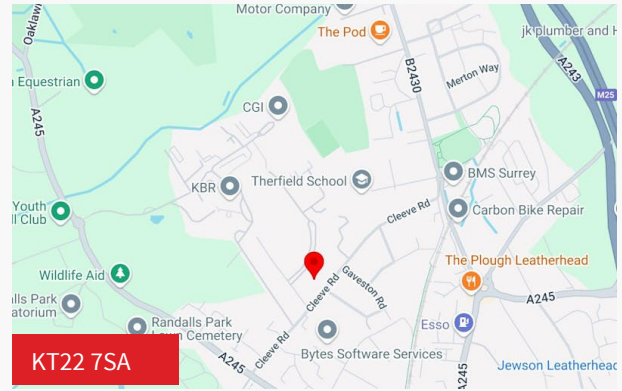
