LOCATION

The yards are situated in Middlemuir, just 8 miles north of Aberdeen City Centre and 8 miles north east of Dyce. The subjects are easily accessible by road, and just 4.5 miles from the Aberdeen Western Peripheral Route (AWPR) which provides great links across Aberdeen.

The surrounding area is a healthy mixture of both commercial, residential and agricultural. Nearby commercial occupiers include G&A Timber, Simpsons Coaches and JB Plant & Civils.

DESCRIPTION

The subjects comprise of two separate secure yards, with a water connection and mains services available in the vicinity.

Yard 1 extends to approximately 24,807 sq. ft (0.57 acres) and offers access from the north elevation through secured gates. The yard is mainly surfaced with gravel and enclosed by steel palisade fencing, along with a hedge on the north elevation.

Yard 2 extends to approximately 22,581 sq. ft (0.52 acres) and has a rectangular shape, accessible from the south elevation via a secure gate. It is surfaced with gravel and enclosed by steel palisade fencing, with a hedge on the north elevation.

RENT

Yard 1 — £14,000 per annum, exc.

Yard 2 — £13,000 per annum, exc.

LEASE TERMS

The yards are offered on a new Full Repairing and Insuring lease for a period to be agreed incorporating rent reviews at appropriate intervals.

ENTRY

Immediate, upon completion of legalities

RATING

The subjects are entered into the current Valuation Roll as follows:

Yard 1 - Rateable Value = £7,000

Yard 2 — Rateable Value = £6,700

The rent quoted is exclusive of VAT, which may be applicable

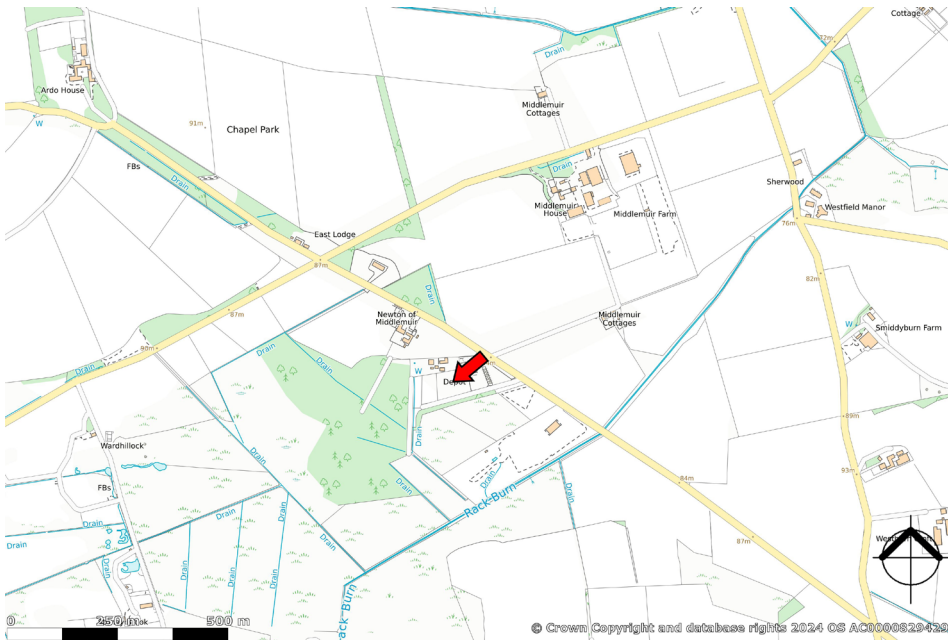
LEGAL COSTS

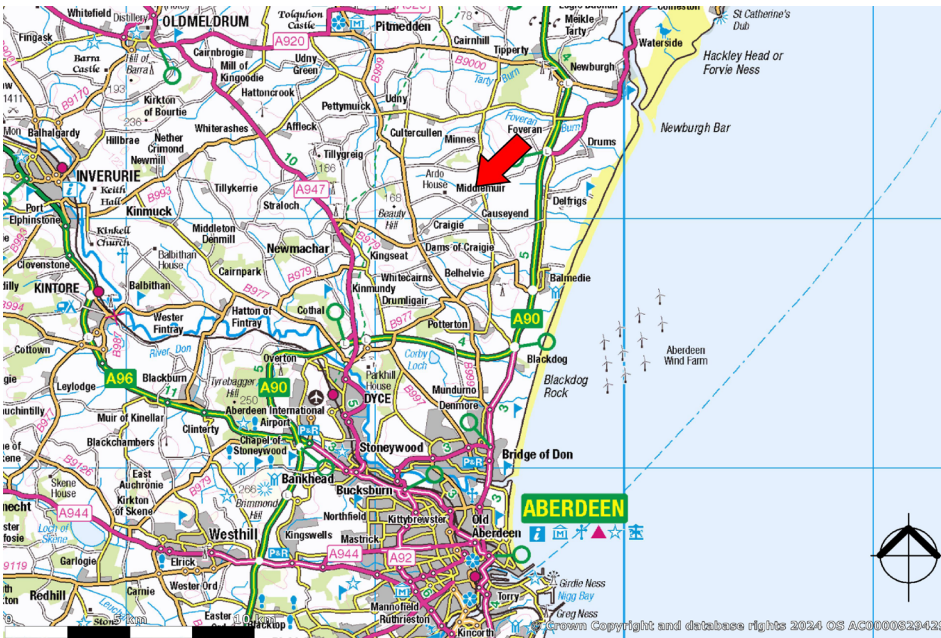
