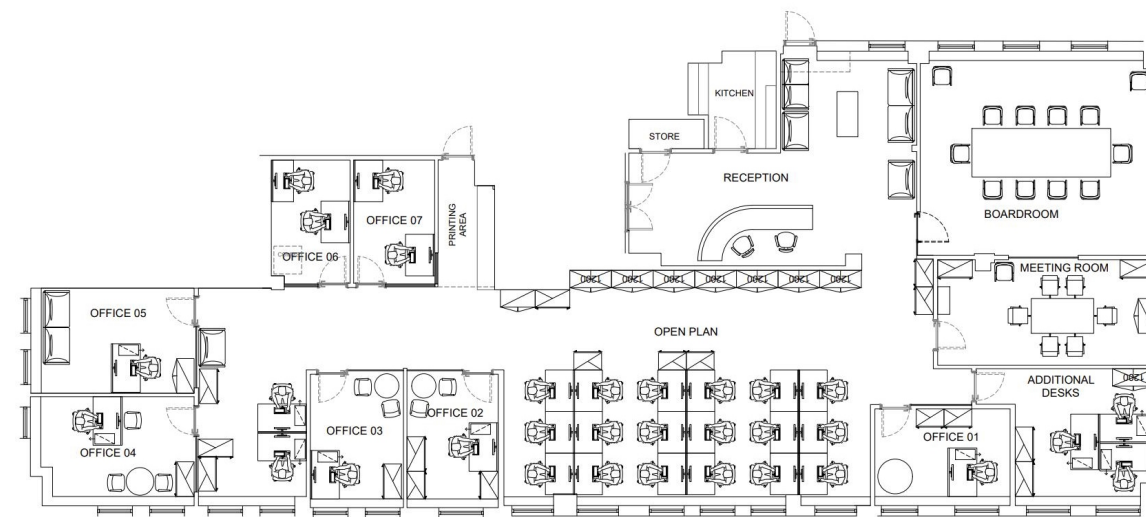
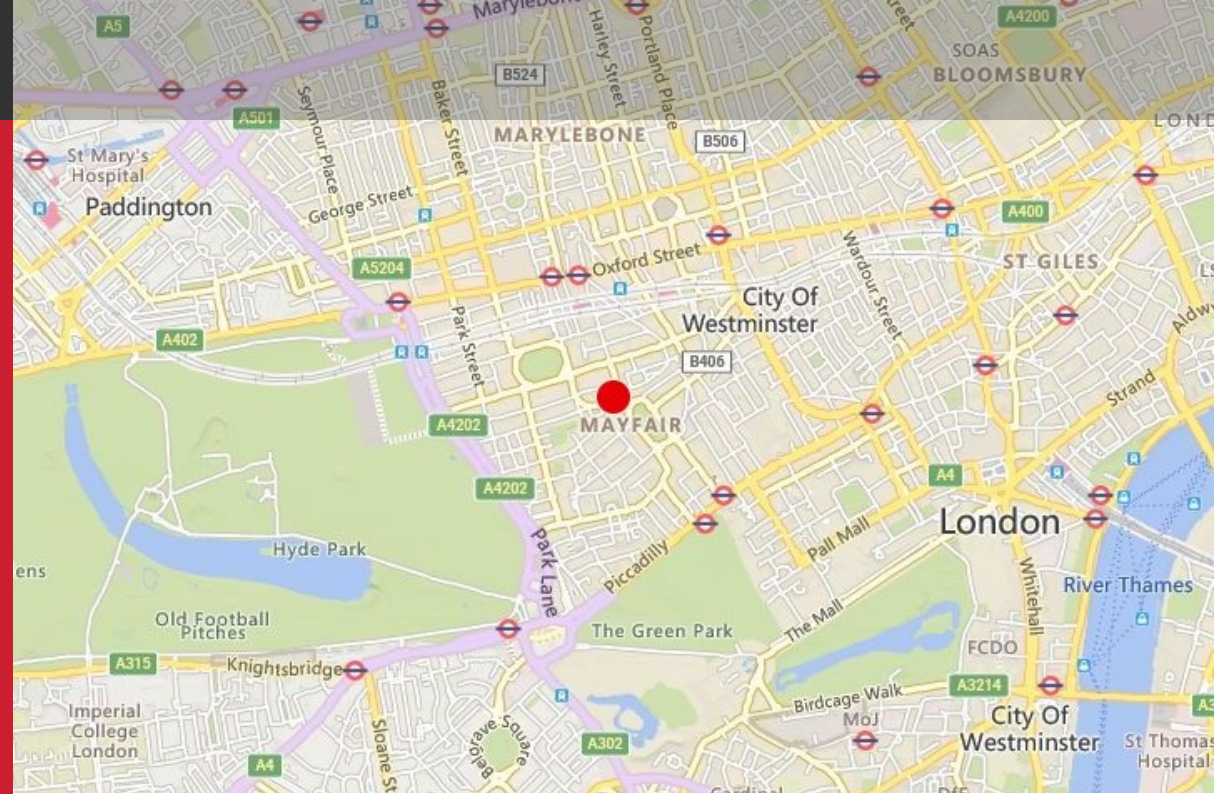
Location
