## Location

## The Premises

The property provides a 'Maison' retail and restaurant opportunity over 5 floors. It is currently fitted out to a top end specification as a restaurant. It has a well equipped kitchen and back of house facilities in the basement; a restaurant and bar area on the ground floor with terrace at the rear; a first floor restaurant/private dining area with bar onto a terrace; an additional private dining area on the second floor; and office facilities on the third floor.
