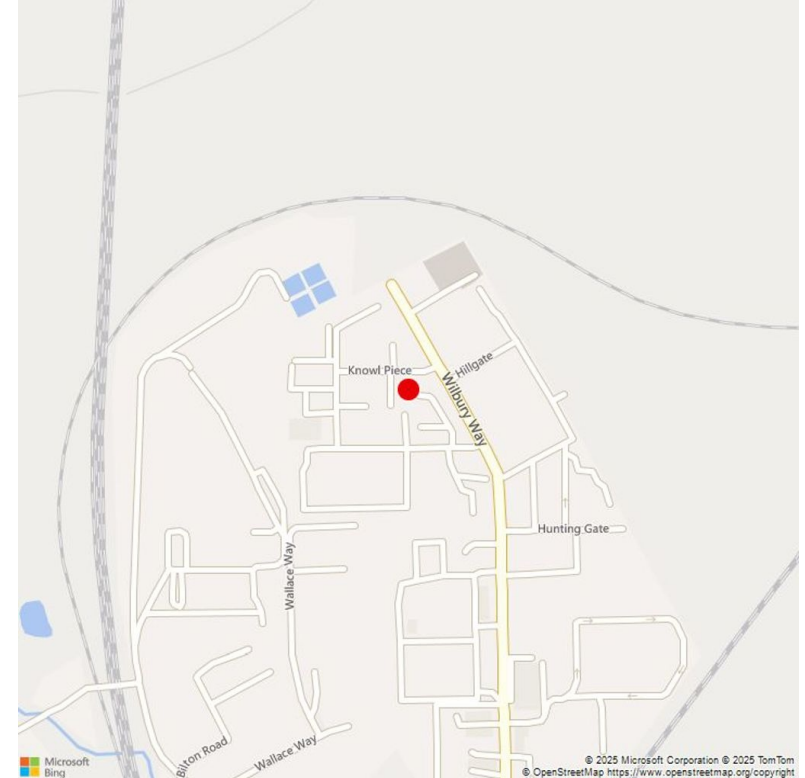

Description

The property comprises a pair of end and mid terraced light industrial units. The ground floor benefits from three WC's, an open plan warehouse and two manually operated steel roller shutter loading doors with a height of 4.84m.

The first floor has been fitted out as offices, with a kitchen break out area for staff. The offices have a suspended ceiling, LED lighting and separate meeting rooms.

The warehouse has a painted concrete floor with a height to eaves of approximately 5.76 metres, whilst the height to the underside of the ridge is 5.23m. There are loading and parking areas in front of the units which can accommodate six cars.

Location

Hitchin is a busy North Hertfordshire market town located approximately 35 miles north of London. Road communications are good with the A1(M) providing access to the M25.
