LOCATION

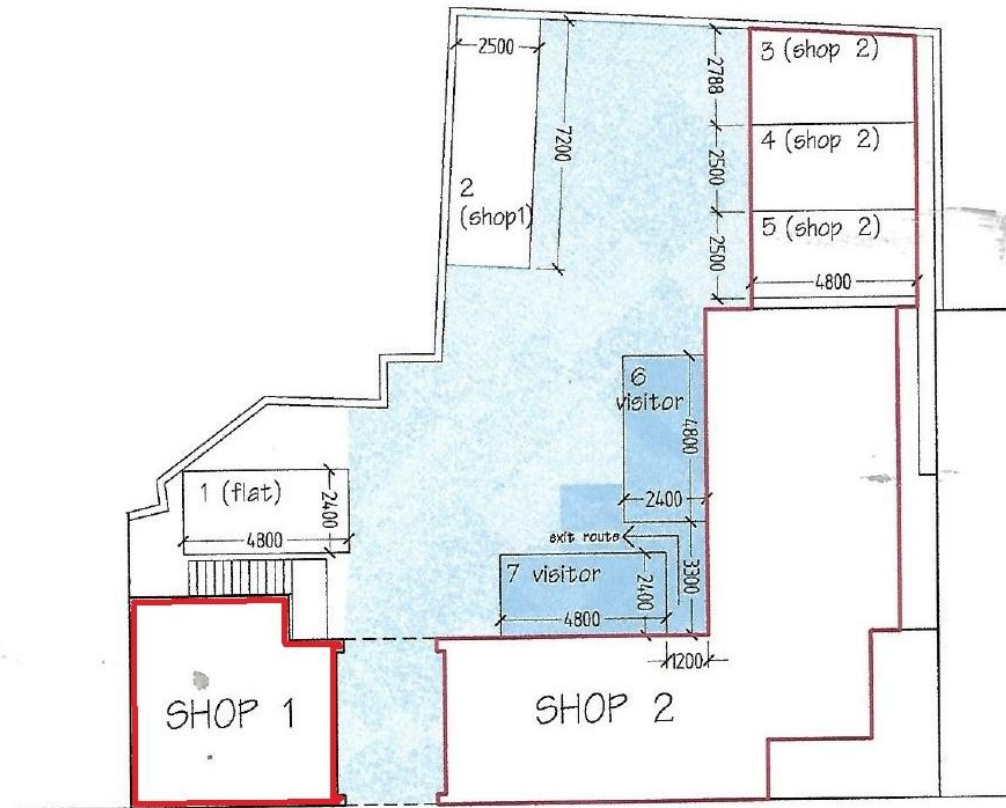
