Location & Description

Bartletts Court is located on the A4 to the west of Maidenhead, within close proximity to the A404M and J8/9 of the M4, with onward access to the M25, M40, Heathrow Airport and London.

Both Maidenhead and Twyford rail stations are less than 10 minutes' drive from the property.

There are two pubs / restaurants within walking distance of the offices, one of these is accessed via a picturesque footpath across the farmland.

The Hay Barn is a high specification self-contained office, set within a peaceful open setting. For a relatively small office the property offers an impressive barn conversion environment, with exposed oak beams within a vaulted ceiling and ample natural light.

The accommodation is open-plan and benefits from comfort cooling, perimeter trunking, carpeting, cat 5 cabling, fitted kitchen, WC & shower.

Externally there is a communal lawned courtyard, for use by the tenants for BBQ etc and allocated car parking for 3 cars, with additional overflow parking available on site.

The property not only suits office use, other usage, such as medical or one-on-one personal training, would also be considered.

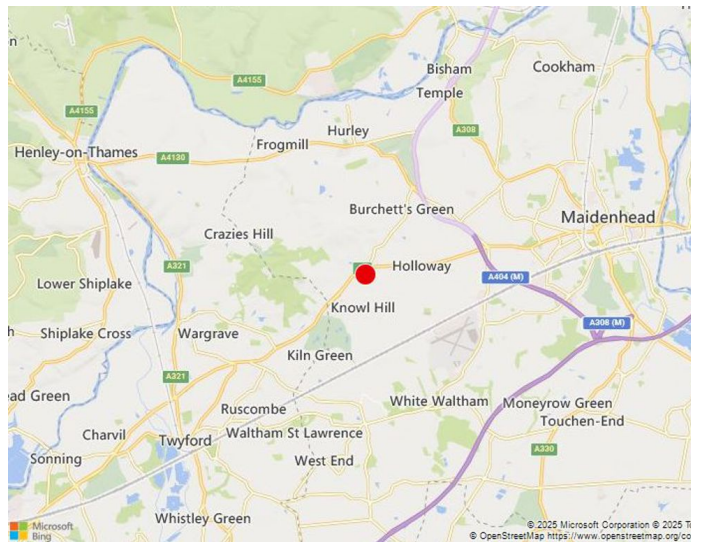
