













Contemporary office space within a historically interesting and renowned period building

Four Millbank benefits from an on-site Crussh juice bar and fully equipped Bannatyne's Health Club with a swimming pool.



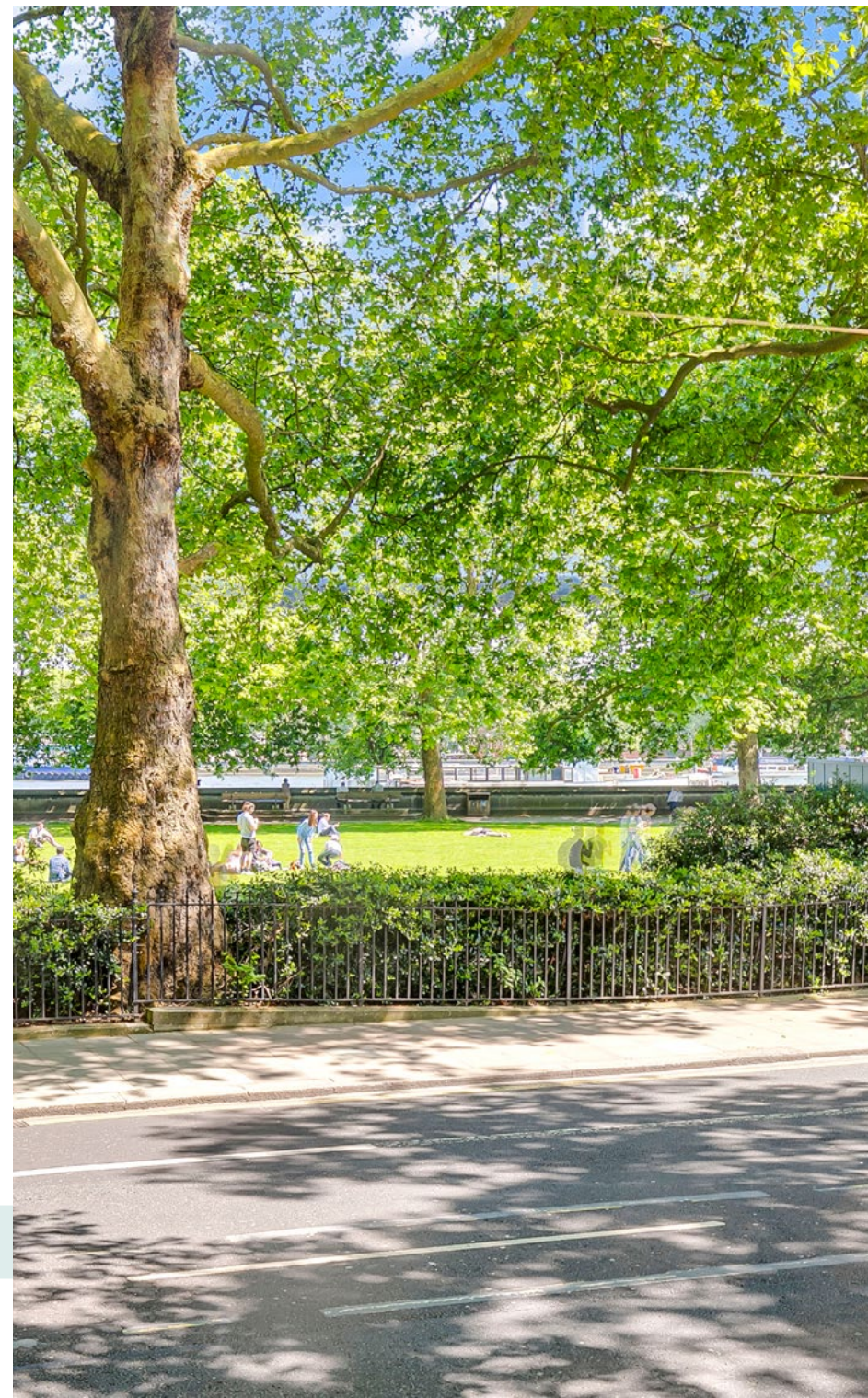

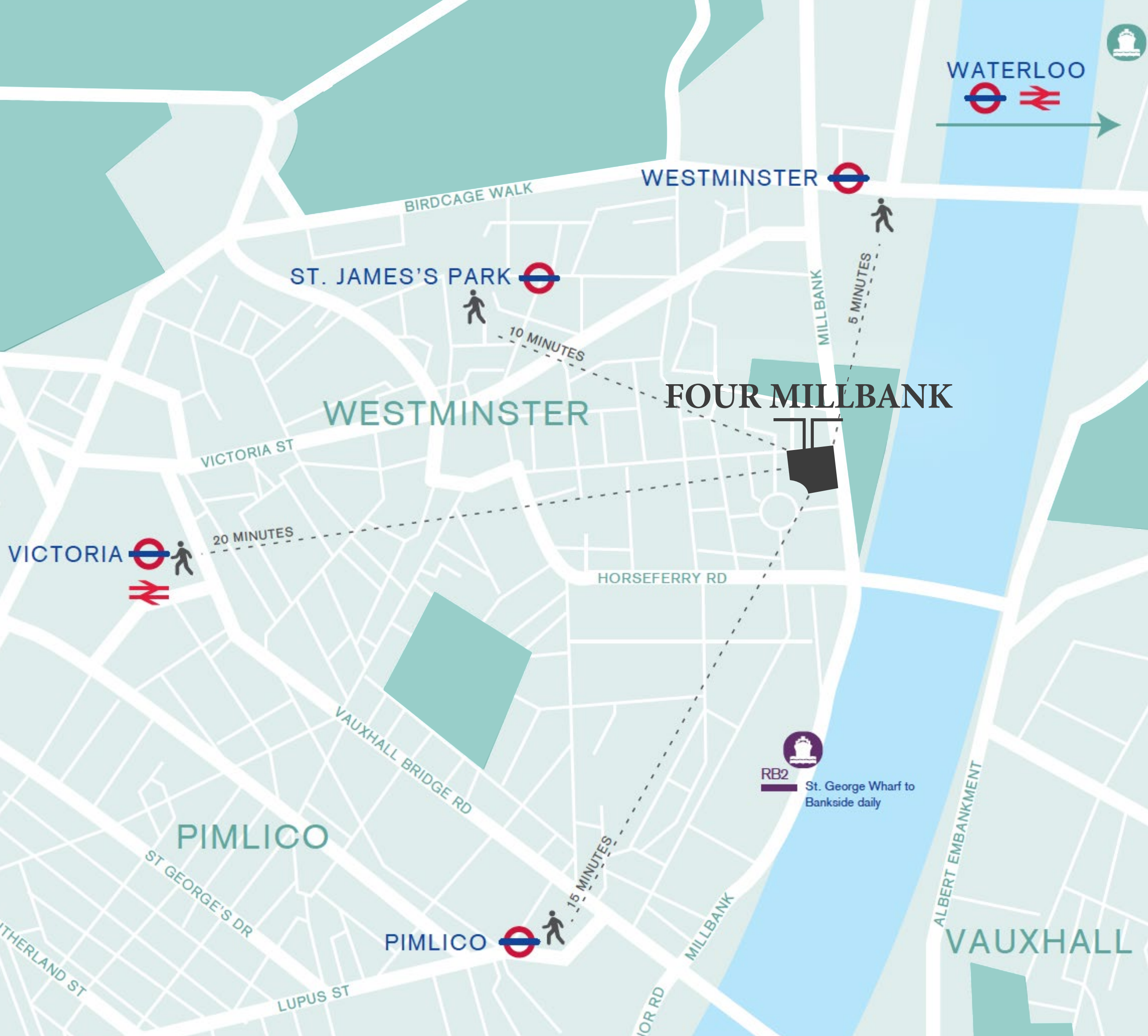


Upper Ground Floor Suite

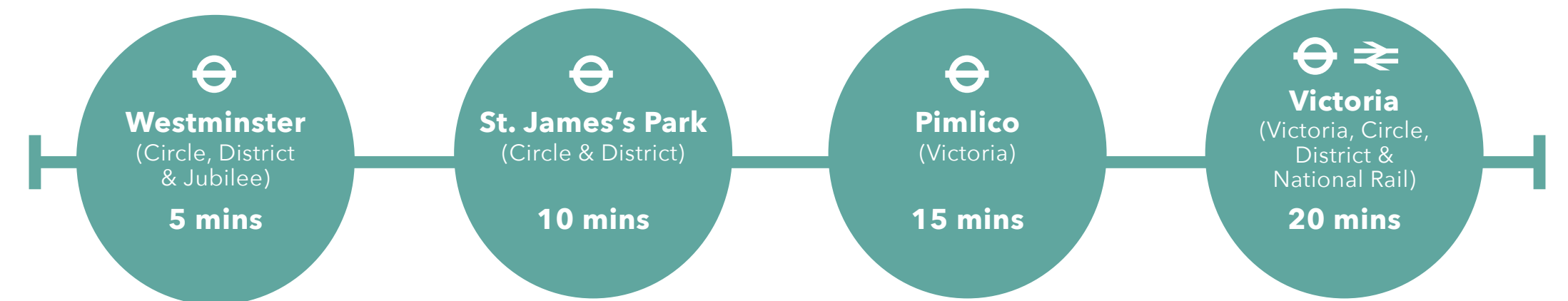
Route to office space
