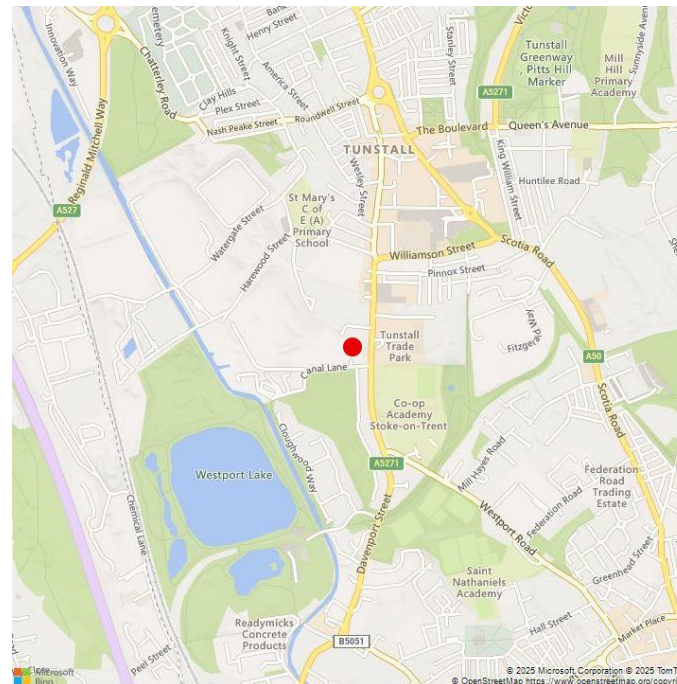
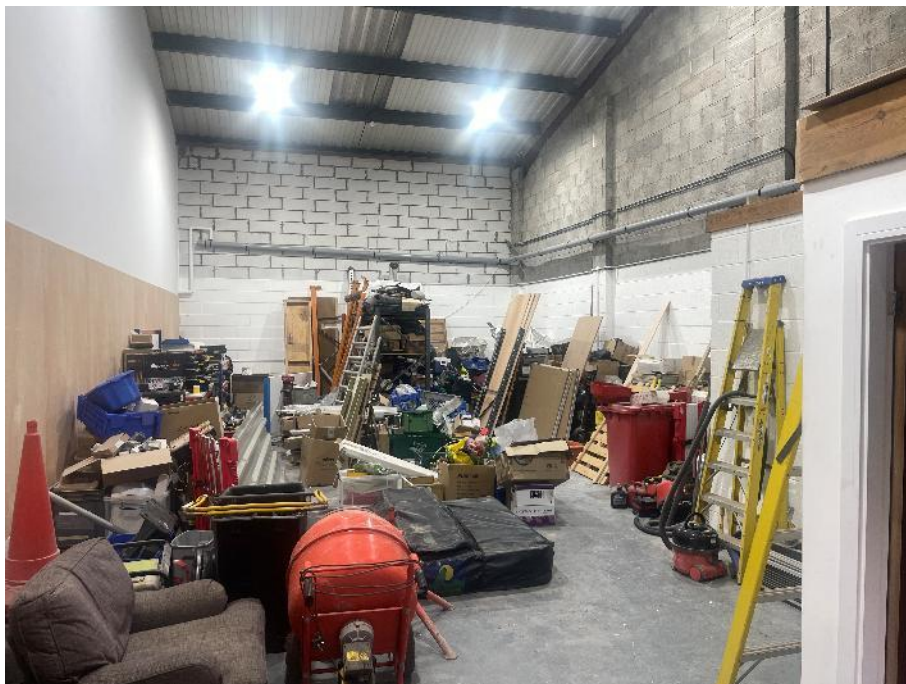
Location

The property is located on Brownhills Business Park approximately 0.30 miles to the south of Tunstall town centre, off Brownhills Road (A5271) within easy reach of the A500/A50/A34 and the M6 motorway.

Description

The property comprises a mid-terrace industrial unit of portal steel frame construction with brick and insulated steel sheet clad elevations under an insulated steel sheet clad roof. To the front of the unit there is a car park in shared use with the other units on the Business Park.

Measured internally the unit has approximately 5.10m (16ft 8') eaves and is approximately 15.00m (49' 3') deep and 6.82m (22' 5') wide. The unit has a 3.63m (11' 11') loading door to the front elevation and provides open plan workshop/storage space together with a small office, kitchenette, shower and toilet.
