Location

The property is located on St Kenelm Court which forms part of Coombs Wood Business Park, Halesowen.

Halesowen town centre and Birmingham city centre are located approximately 1.5 and 7.5 miles distant respectively. National motorway access is provided by Junctions 2 and 3 of the M5 (within 3 miles distant).



Description

Constructed in 2006, St Kenelm Court comprises a contemporary office development with car parking and landscaped grounds.

The property comprises a two storey mid terrace office building. The ground floor provides a reception area with male and female WC facilities and direct access to open plan offices with a kitchen.

In terms of specification, the offices consist of:

- Suspended ceilings.
- LED lighting.
- Perimeter trunking.
- Gas central heating.

The reception area also provides access to the first floor which has been let separately.

Externally, 6 allocated car parking spaces are provided. Visitor and disabled car parking spaces are also provided for the shared use of all occupiers.

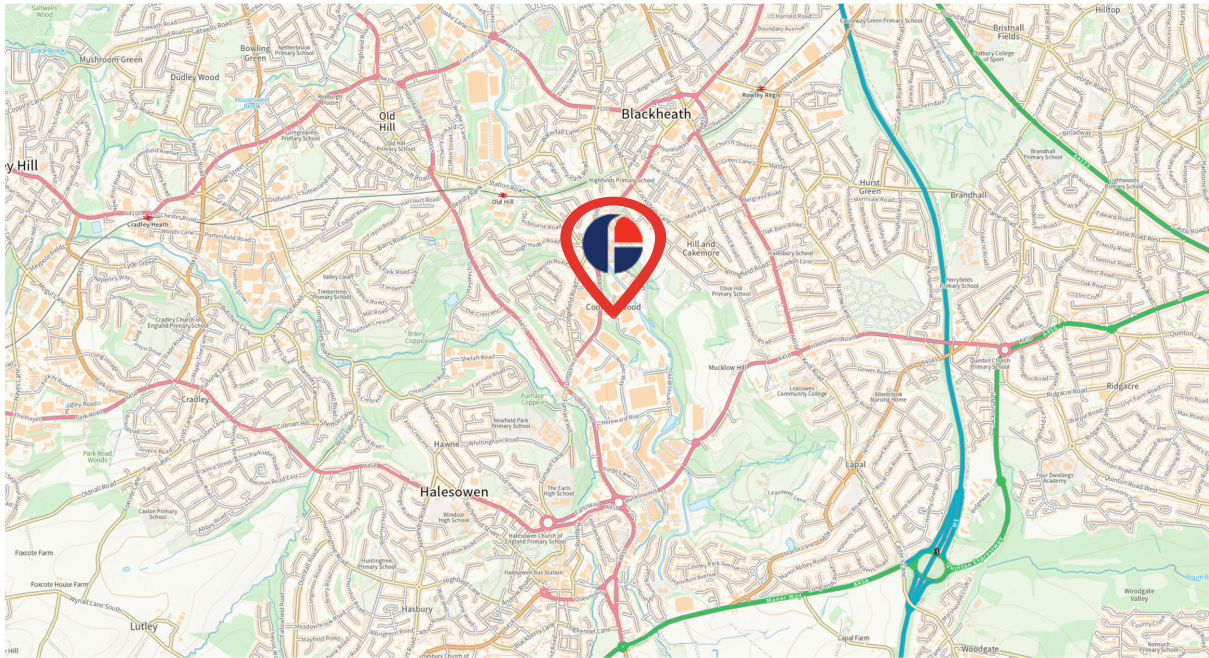

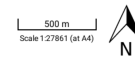
