Location

Penzance is a historic market and harbour town in West Cornwall. With a population of 20,000 it functions as the main commercial, transport and cultural centre for the West of Cornwall. Easy transport links with the nearby A30 and Penzance station (mainline to London Paddington). The town's harbour remains active notably as the mainland terminal for ferry services to the Isles of Scilly, reinforcing its role as a gateway to the far southwest.

Market Jew Street is often described as the main shopping street in Penzance which runs through the heart of the town centre and acts as a key thoroughfare linking transport, commerce and civic life. It is characterised by a mix of independent shops, national retailers, café, pubs and services making it one of the busiest parts of town.

Description

A mid terraced, four storey period building of traditional rendered masonry construction under pitched slate and flat roofs. Internally, it is arranged to provide a retail sales area with ancillary to the rear on the ground floor together with further ancillary storage and staff accommodation to part of the first floor.

A self contained maisonette extends over part first, second and third floors which has been sold off on a long leasehold interest.

Parking

There is a rear car park (Bread Street) with 2 spaces (1 retail and 1 maisonette).

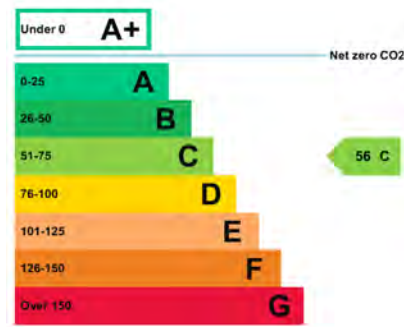

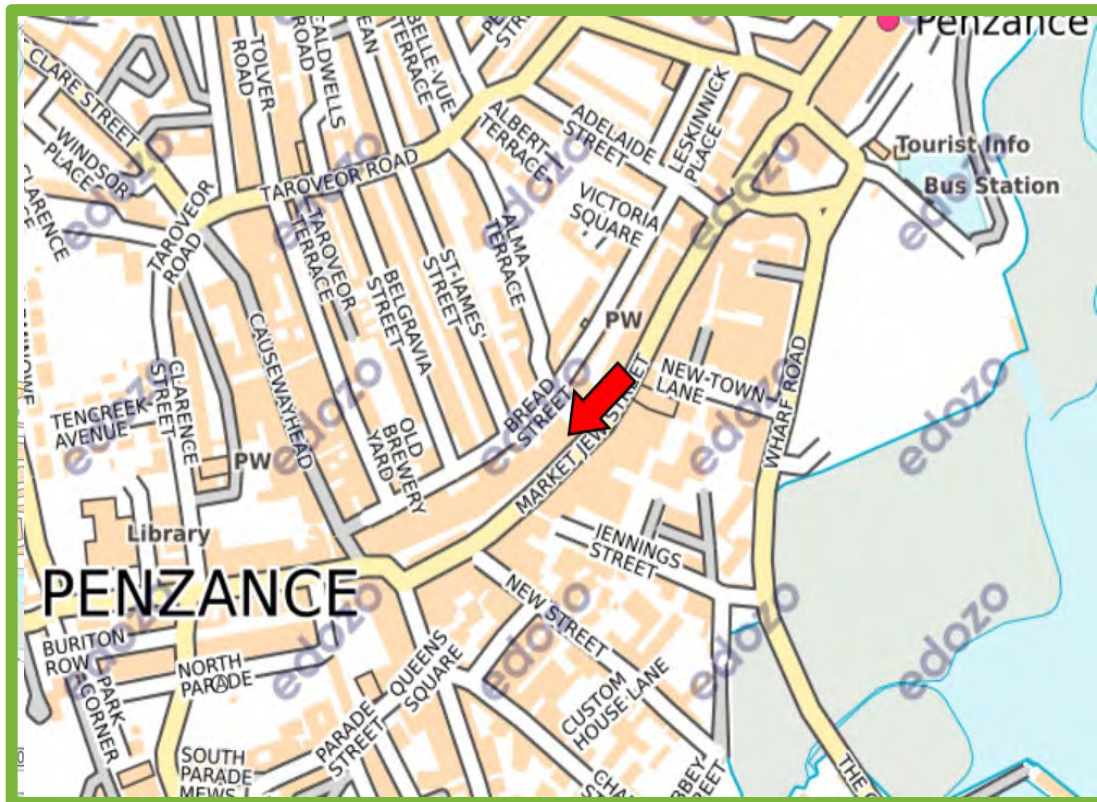
