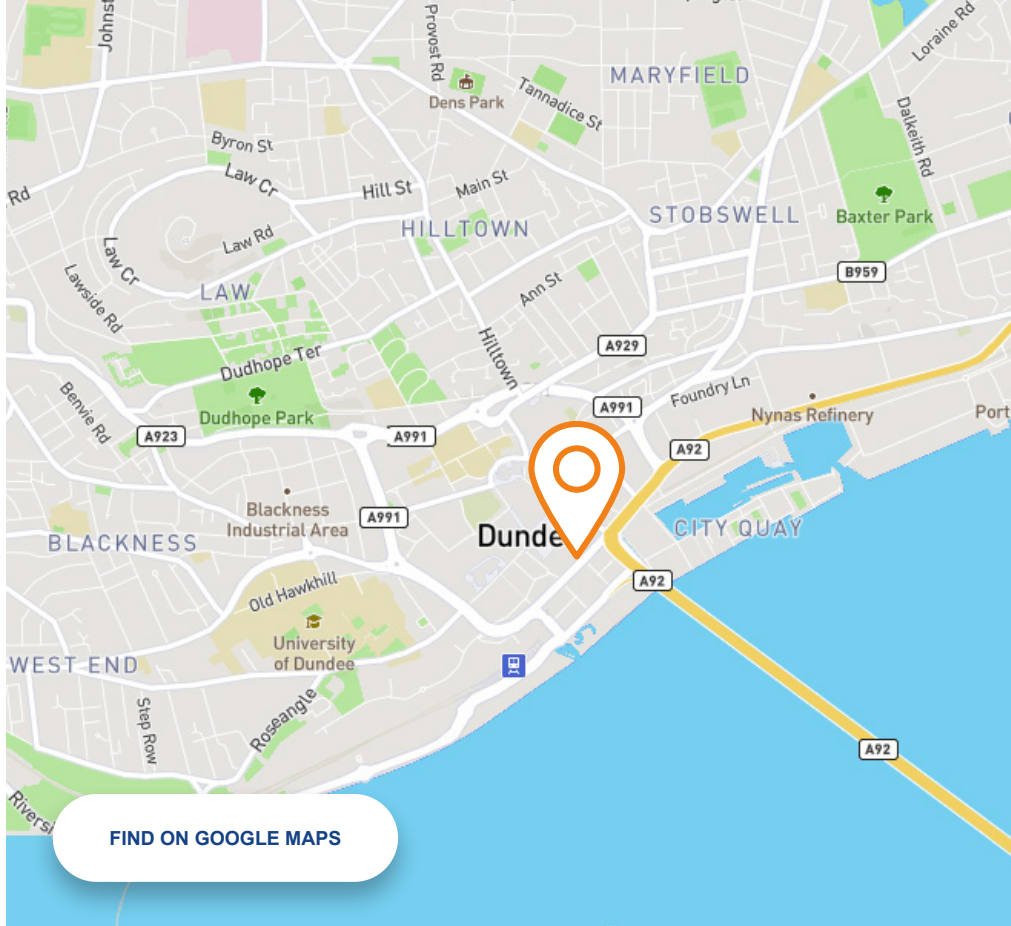

LOCATION

The subject property is situated on the south side of High Street, one of the prime retail pitches within the city. High Street together with Murraygate, forms a link between the two city centre shopping centres, Wellgate and Overgate.

The subjects are in close proximity to the Dundee Waterfront Area which is currently undergoing a multi-million pound redevelopment comprising commercial and residential use to reconnect the city with the River Tay to the south. The Victoria & Albert Museum forms the central attraction of the Waterfront Area.

Dundee is the fourth largest city in Scotland, with a resident population of approximately 150,000 and a regional catchment population estimated at 330,000. Dundee sits on the east coast of Scotland, approximately 65 miles north of Edinburgh and a similar distance south of Aberdeen.

DESCRIPTION

The available unit comprises part of a traditional four storey building comprising retail unit at ground floor with ancillary space and storage on the lower level. Service access is available directly off Crichton Street.

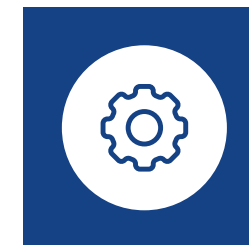
