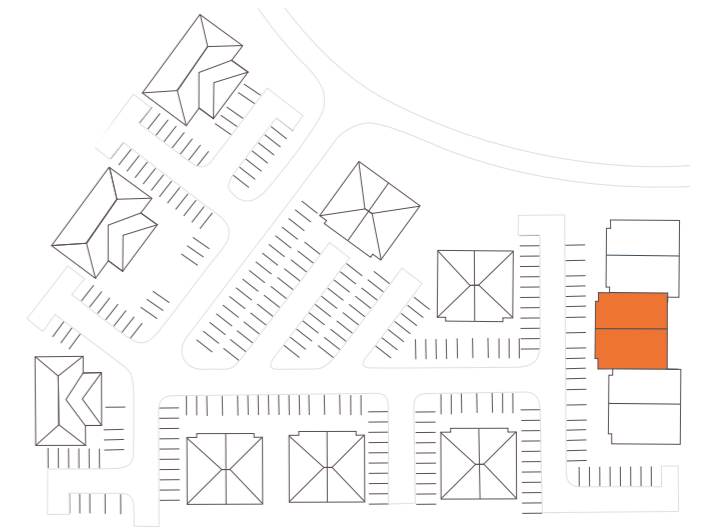


FIRST FLOOR
