Location

The subjects are located within the Tollcross area of Glasgow on the south side of Tollcross Road immediately opposite its junction with Amulree Street and approximately four miles east of Glasgow city centre.

Tollcross Road is a main arterial route with high volumes of passing traffic that connects with the city centre via the Gallowgate travelling west and Mount Vernon travelling east.

Convenient M74 motorway access is provided 0.5 mile south via Junction 2A that connects with the M73, M74 and M8 beyond. Access to public transport links are provided with regular bus routes operating on Tollcross Road itself whilst Carmyle Train Station is a 15-minute walk away south.

Nearby occupiers include Arnold Clark, Motorpoint, Van Monster, Direct Flooring, Starbucks, McDonald's, KFC, Sterling Furniture, Matalan and Dwell.
