**DESCRIPTION**

The property, which is currently undergoing refurbishment, comprises a mid-terrace warehouse / industrial unit of steel frame construction below a pitched, lined roof incorporating rooflights.

**LOCATION**

The Eldon Way Industrial Estate is a well known industrial and warehouse centre of around 50 units close to the town centre on the western side of the Maidstone Road (A228). The town's shops and main line station providing frequent service to London and Ashford are within 300 yards. Paddock Wood is 5 miles from Tunbridge Wells and 10 miles from Maidstone. The M25 and M20 / M26 motorways are around 14 and 19 miles to the north respectively, the latter being reached via the East Peckham by-pass and Seven Mile Lane.

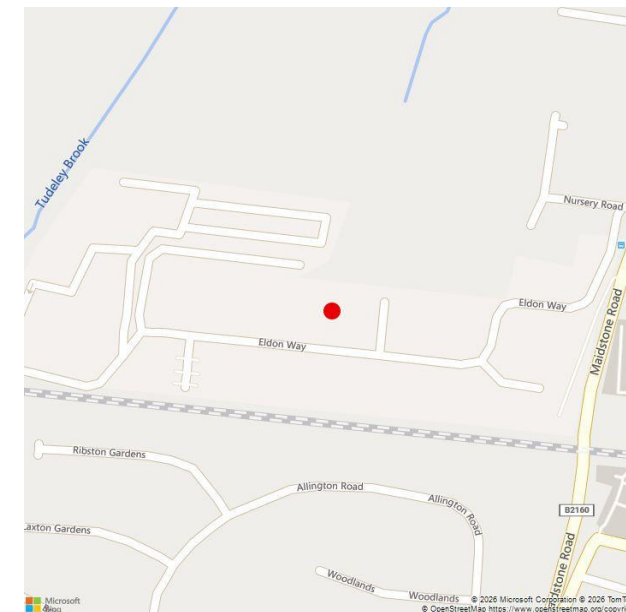
