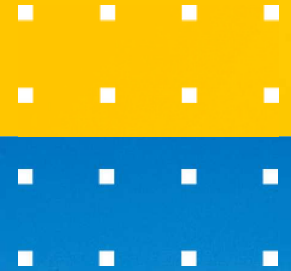

LOCATION

Upton is an attractive village some 2 miles to the east of Southwell, a location which offers relatively direct access into the regional centres of Newark and Nottingham. The village has one pub and lies within the catchment area of the Minster School in Southwell. Southwell is a thriving Minster town, having a useful range of town centre amenities and professional services, grouped principally along the period street scenes of Queen Street and King Street. Southwell schooling is of a renowned standard across the age ranges and the town offers an extensive range of sporting and cultural activities.

SITUATION

The property occupies a prominent position fronting Main Street to the west off which it has direct access, close to its junction with Hockerton Road.

HISTORY

Upton Hall is the headquarters of the British Horological Institute.

Earliest records trace back to 1335 when the Hall was the residence of Robert Bagenham, on lands granted by King Edwy to Archbishop Osgytel of York in 956. The Hall has witnessed centuries of history, including surviving the plague in the 1620's when it was home to Owen Oglethorpe. A section of the Elizabethan-era Oglethorpe's Hall still stands as part of the current structure.

By 1795, it came under the ownership of Robert Smith, later known as Lord Carrington.

In 1829 Thomas Wright, a notable figure in Nottingham's banking sector and the High Sheriff of 1811, commissioned architect William Donthorne to re-build Upton Hall. Donthorne, a founding member of the Royal Institute of British Architects, designed the Hall in the fashionable Neo-Classical style, evident in its symmetrical south-facing elevation and Greek-style portico.

John Warwick a director of Warwick & Richardson, a Newark brewing firm, acquired the Hall in the late 19th century, adding a west wing with a ballroom and games room. The Hall's luxury made it a sought after venue for village events. In 1936, Sir Albert Ball purchased the Hall, followed by the Fathers of the Holy Ghost in 1939, who transformed it into a Theological School. During the last war, the Hall was requisitioned for evacuated children.

Since 1972, the British Horological Institute has owned Upton Hall, now a Grade II* Listed building with 72 rooms, it houses the Museum of Timekeeping and the BHI Headquarters.

DESCRIPTION

Upton Hall comprises a substantial country house in the Greek revival style, predominantly being of an early 19th century construction but incorporating earlier medieval and 17th century origins, having been designed by the architect W J Donthorne.

Being Grade II* Listed, the property is of a traditional brick construction principally arranged over basement, and two storeys with stucco and colour wash elevations under a series of interlocking hipped roofs with slate covering and a feature dome parapet beneath which is situated a tetrastyle Ionic portico with pediment.

Externally, the property is approached via an integral service road on the northern boundary which provides for a dedicated car parking area and access to the former stable block. The property sits within substantial landscaped grounds which are generally level in topography although gently sloping towards the south / east and are comprehensively planted with a variety of mature trees. Of particular note are several fine Wellingtonia and a Cedar of Lebanon. In addition, there are two adjoining paddocks.

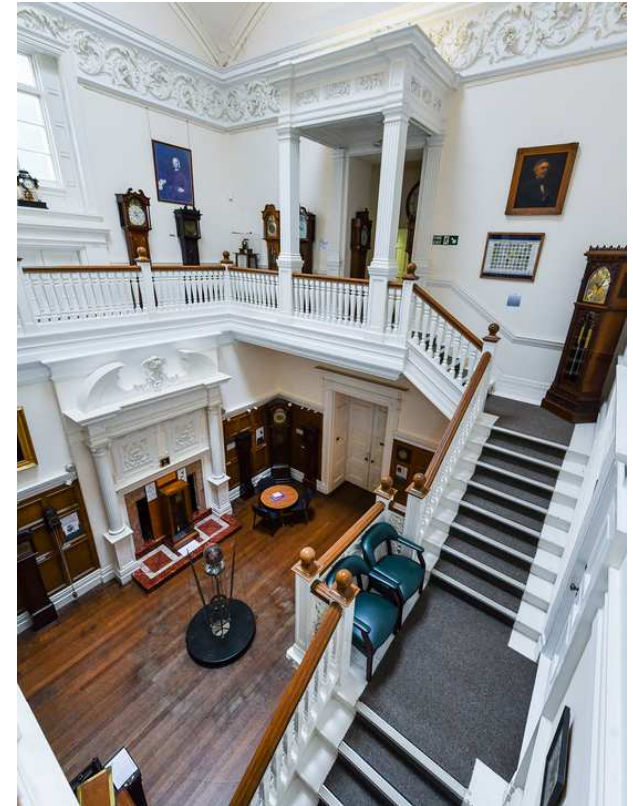
Forming part of the entrance to the grounds is a Greek revival style Triumphal Arch which is Grade II Listed in its own right, incorporating original facsimiles of the Elgin marbles.

Internally, the property is extremely well appointed being configured in a traditional arrangement of rooms and of particular note is the double height inner hall with cantilevered staircase and galleried landing. In addition, the ballroom with theatre and feature two storey bow window with Ionic pilasters and three curved sashes.

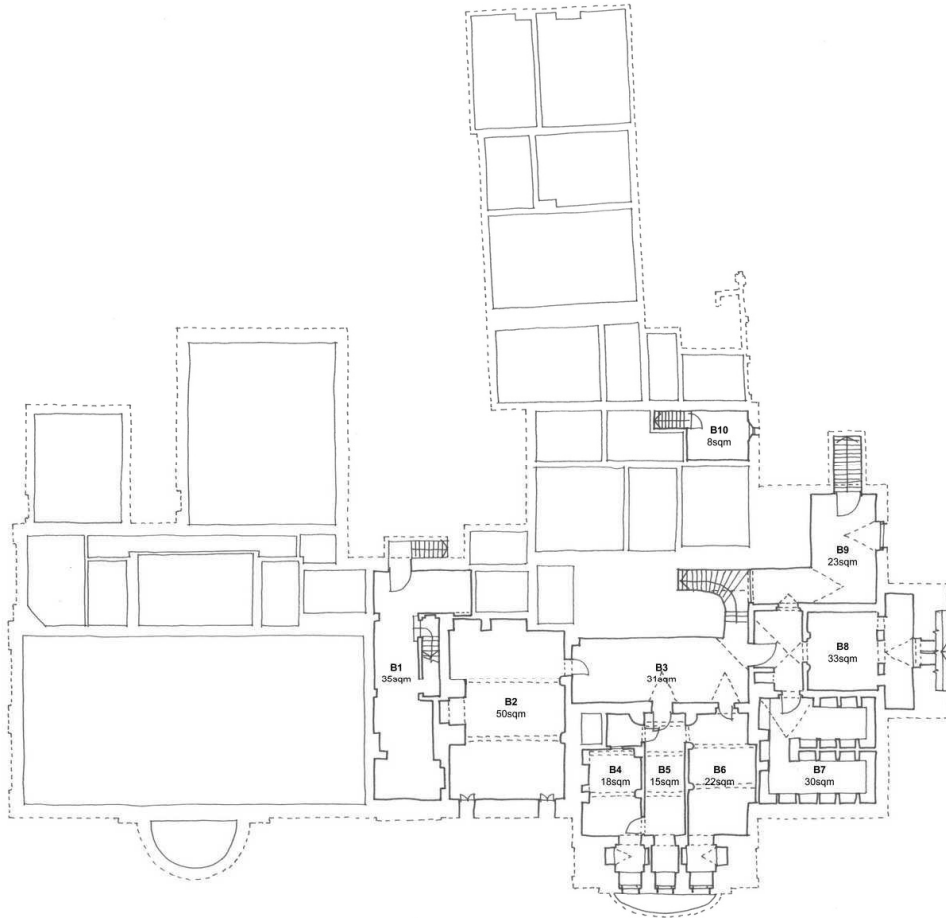

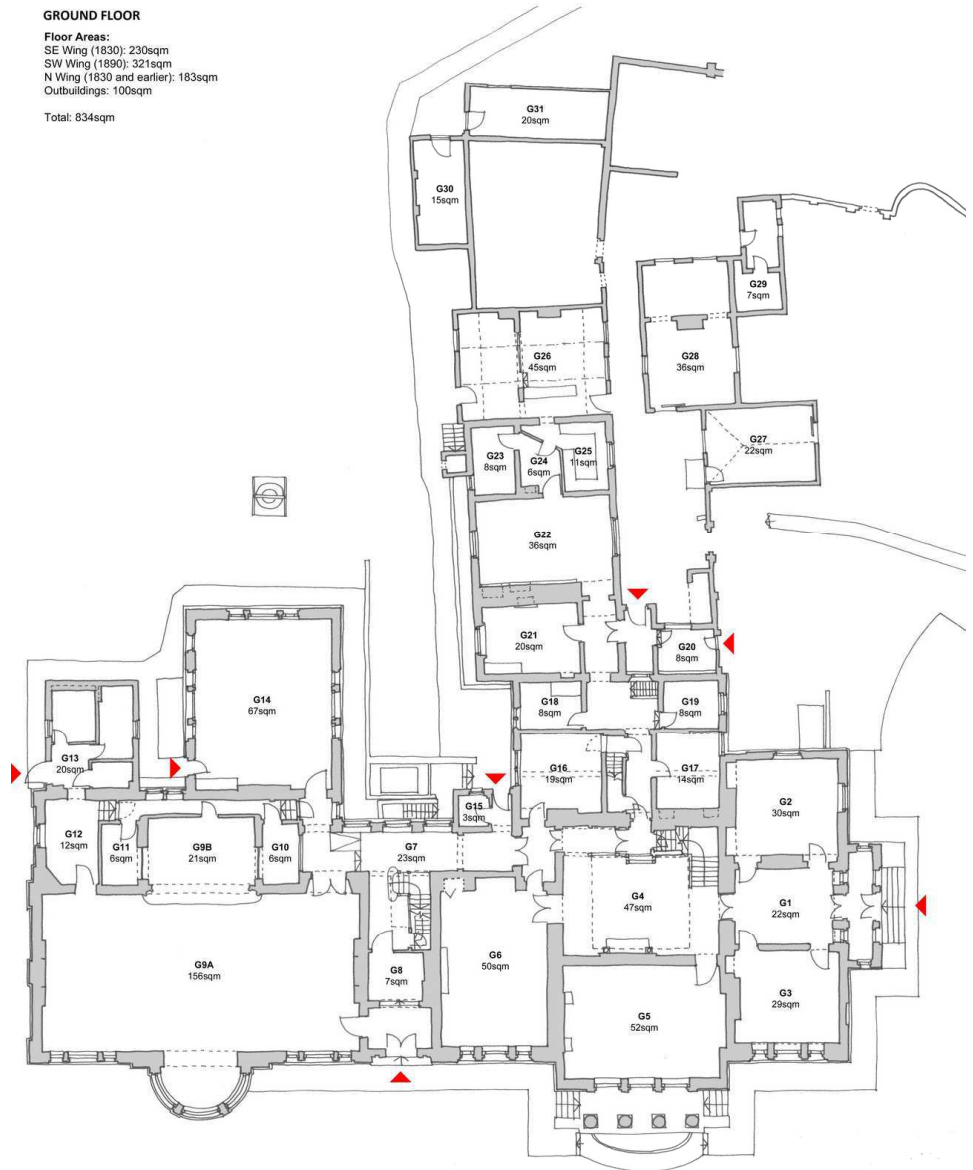

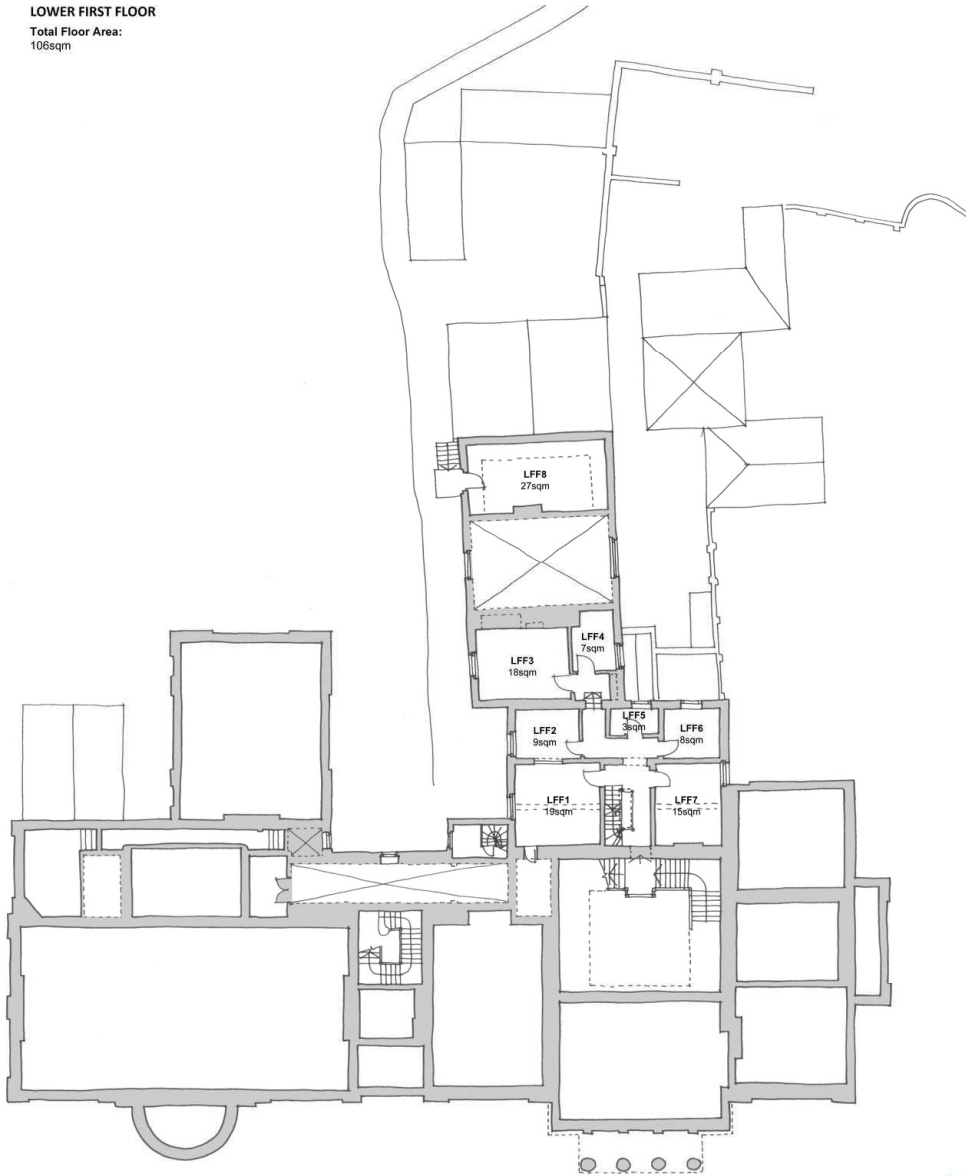

UPPER FIRST & SECOND FLOORS

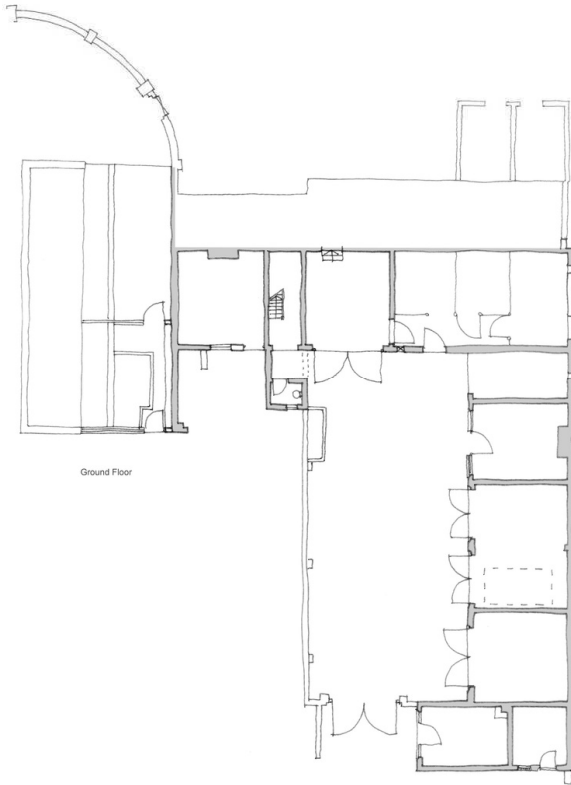

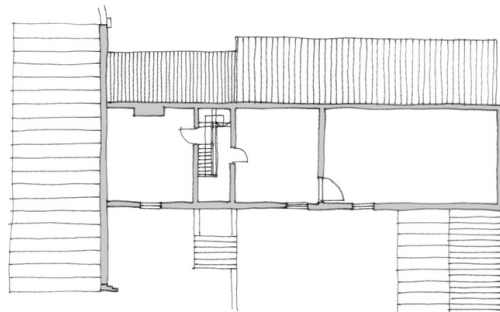

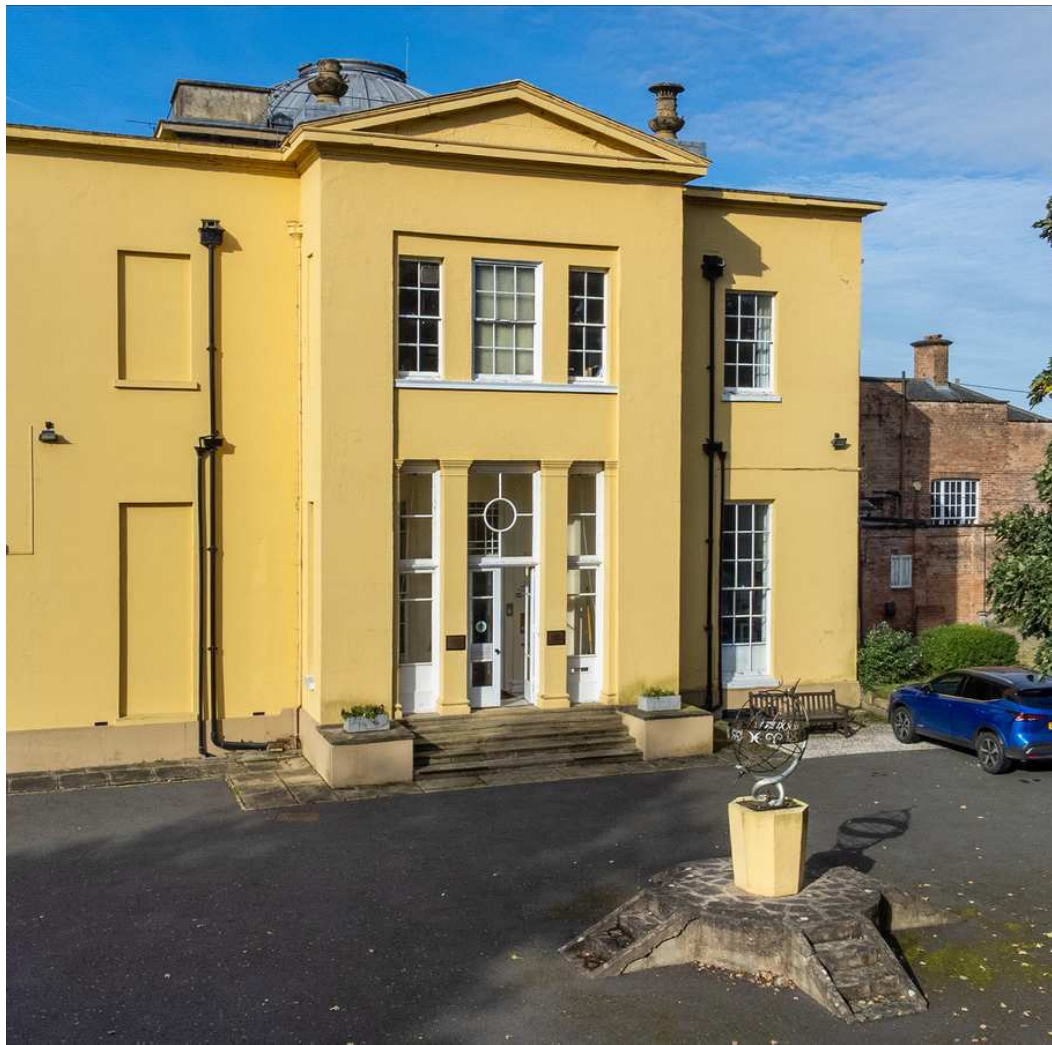
