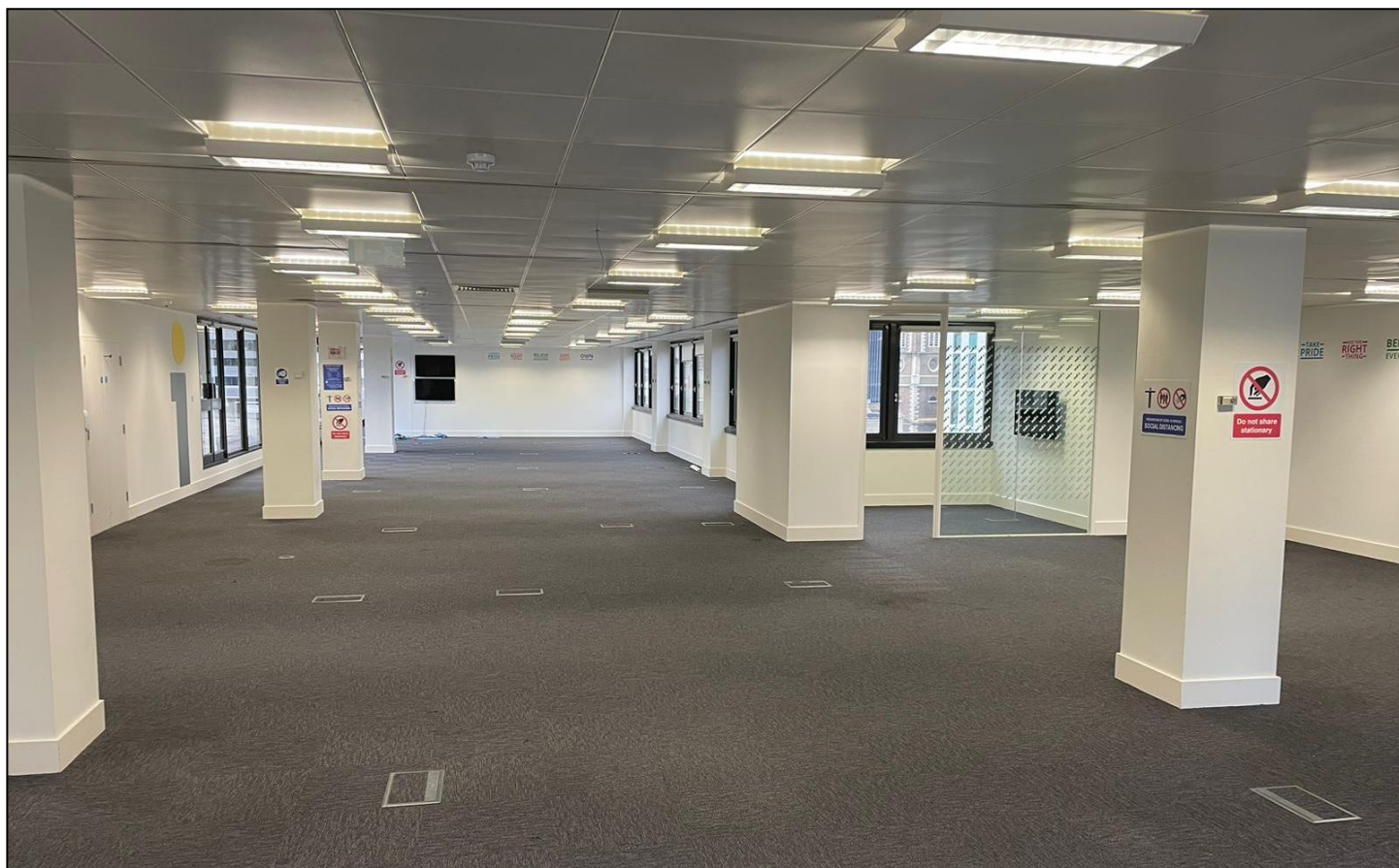

**LOCATION**
