DESCRIPTION

Two units of steel portal frame construction with brick and block walls under dual pitched cement sheet roof with lining panels incorporating translucent rooflights. Minimum eaves heights are 4.5m (14.75 ft) rising to 7.8m (25.5 ft) at the apex and they are served by concertina style loading doors 3.5m (11.5 ft) wide by 3.67m (12 ft) high. Externally there are forecourt parking/loading areas.

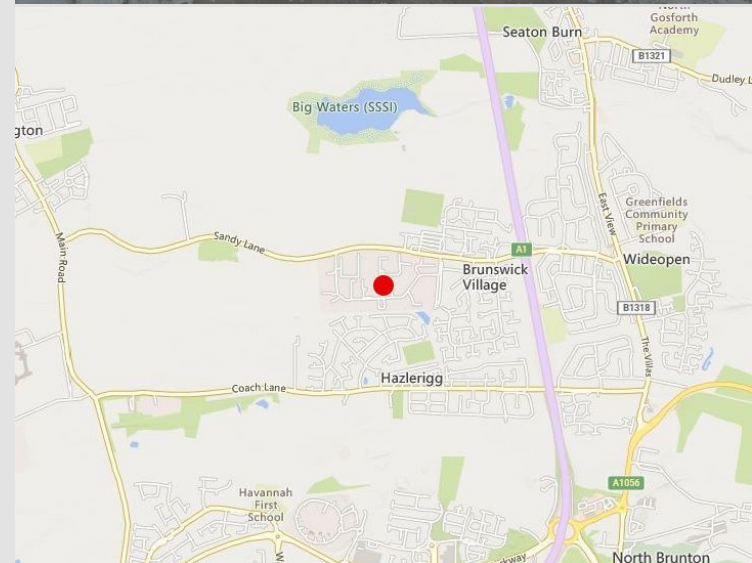
