Dronfield is a busy affluent market town some 8 miles south of Sheffield and 6 miles north of Chesterfield. The local catchment population within 20 km is C 967,000.



DESCRIPTION

The accommodation comprises Unit 8 which fronts Dronfield Civic Centre. Internally the property is partitioned to provide an office and separate WC.

A full development scheme is in consultation to increase the flexibility of the retail parade including enhancing the public realm.
