LOCATION

The industrial unit is located on the popular Whitestone Business Park which is located just off the A4103 Hereford to Worcester Road giving easy access to cathedral city of Hereford (3 miles) and 11 miles from Ledbury which provides easy access to the motorway via M50.

DESCRIPTION

A self contained industrial unit of portal steel frame construction with brick and block to the elevations under a pitched, profiled and insulated roof. The unit includes office space with WC and kitchen facilities to the rear.
