## SITUATION

Whitestone Business Park is located on the periphery of Middlesbrough Town Centre and is adjacent to Borough Road. Road links nearby include Marton Road and Longlands Road providing good access to one of Teesside's primary trunk roads the A66, which in turn provides access to the national road networks beyond.

## DESCRIPTION

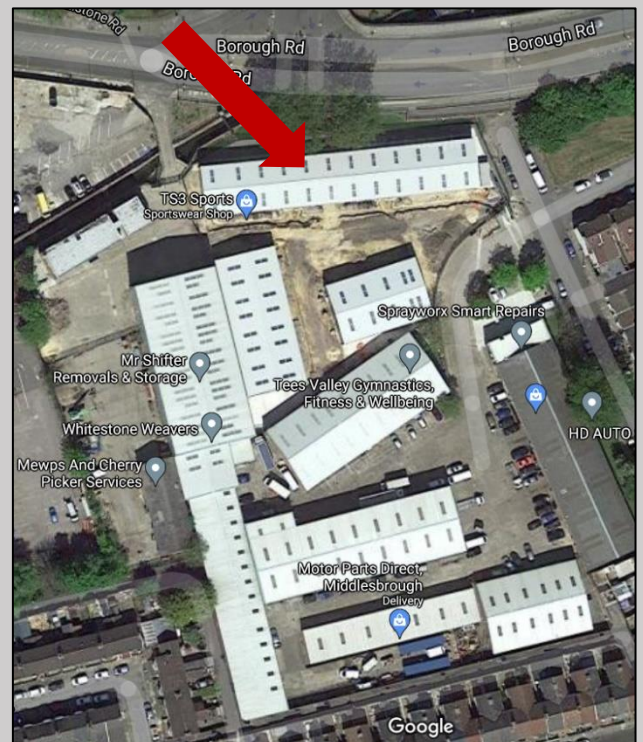
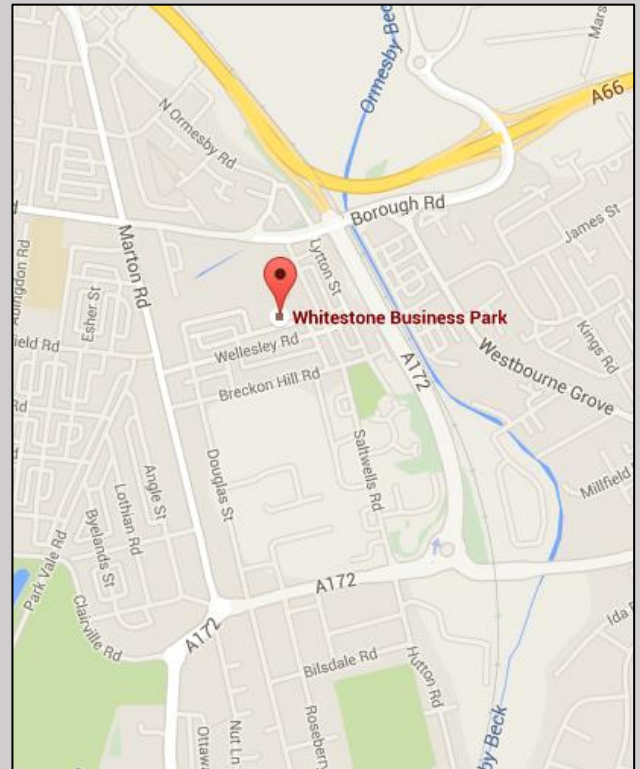
