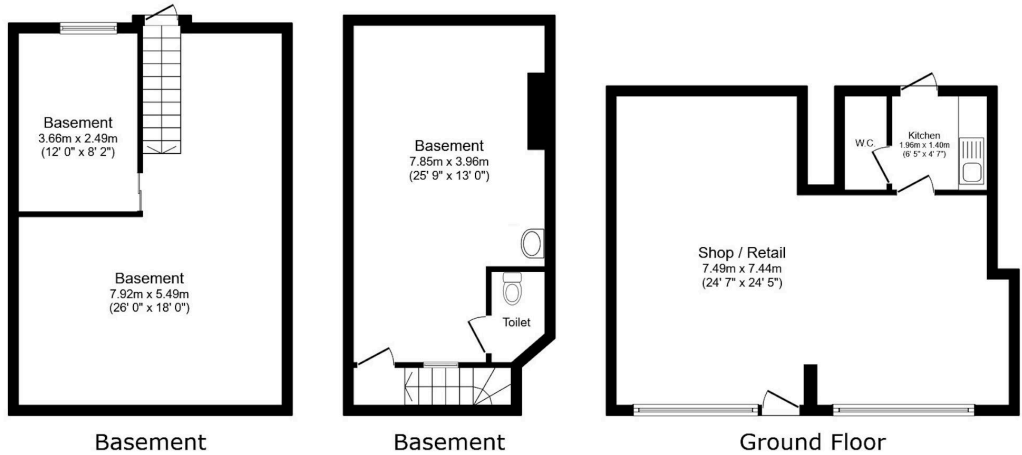
The premises are considered suitable for a range of retail, office and other Class E uses, subject to any necessary consents. The property is available from November 2026.

The current occupier has traded successfully from the premises for in excess of 18 years, demonstrating the strength and longevity of this established trading location.

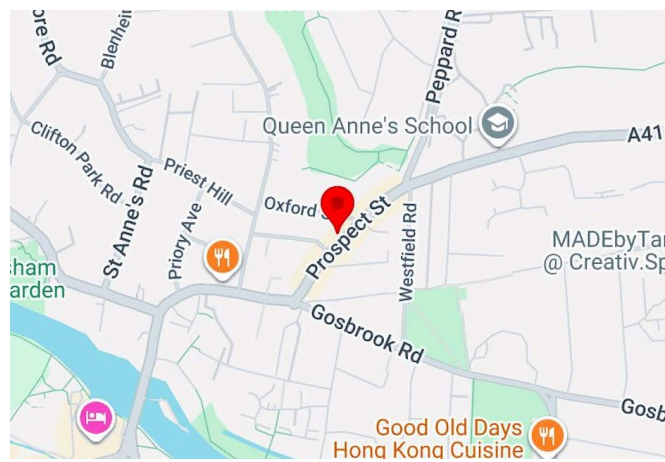
**Location**

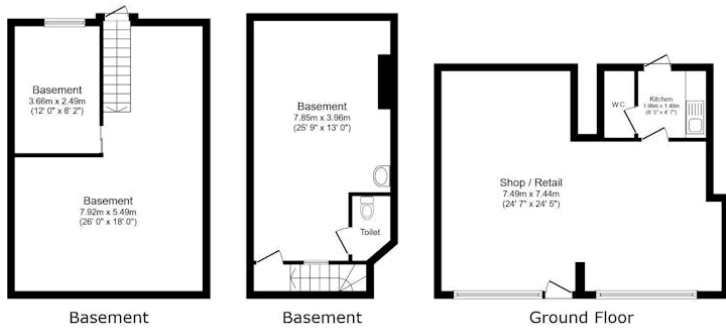
