GENERAL DESCRIPTION

An industrial premises with secure yard space located just off the A53 next to the new Ace Padel centre at Cobridge lights. The premises briefly comprises a detached steel portal frame building with minimum eaves height of approximately 13' " with an internal area of approximately 2,270 sq ft. The property is in good condition with metal profile cladding together with pitched clad roof surface. The building benefits from a variety of workshop rooms, office space, kitchen and bathroom. The wrap around yard provides ample space for storage or the parking of vehicles if required.

LOCATION

The site is located just off the A53 around 1 mile off the A500. Hanley centre is half a mile away and junction 15 of the M6 is accessible in just over 10 minutes by car at around 6 miles away.

SERVICES

We understand that mains water, drainage, gas and electricity is available. No services have been tested by the agents.

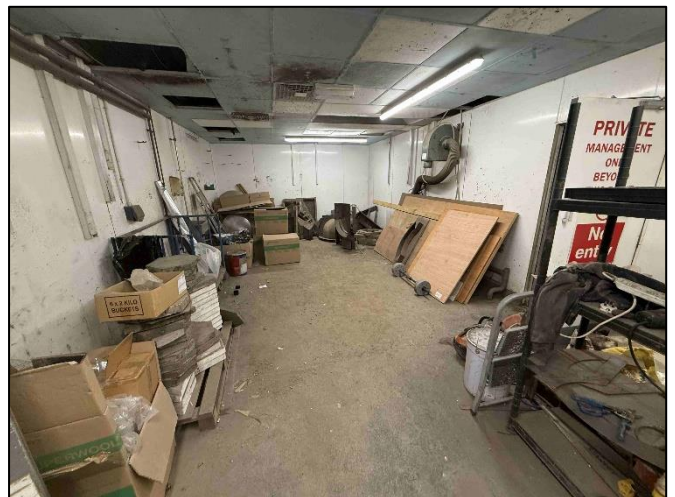

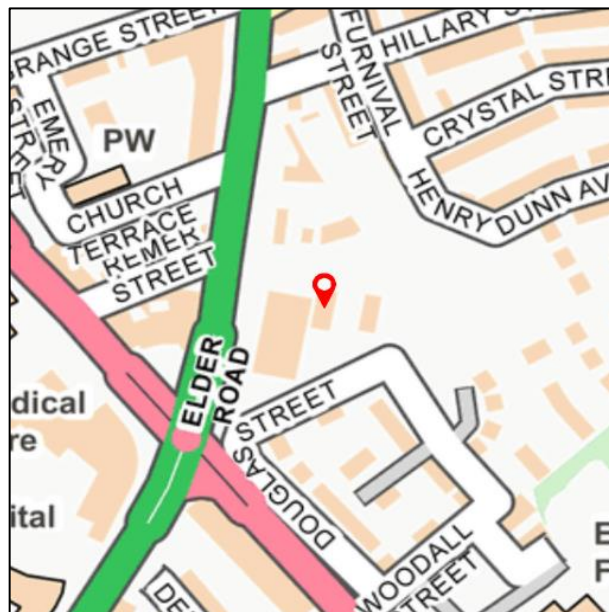
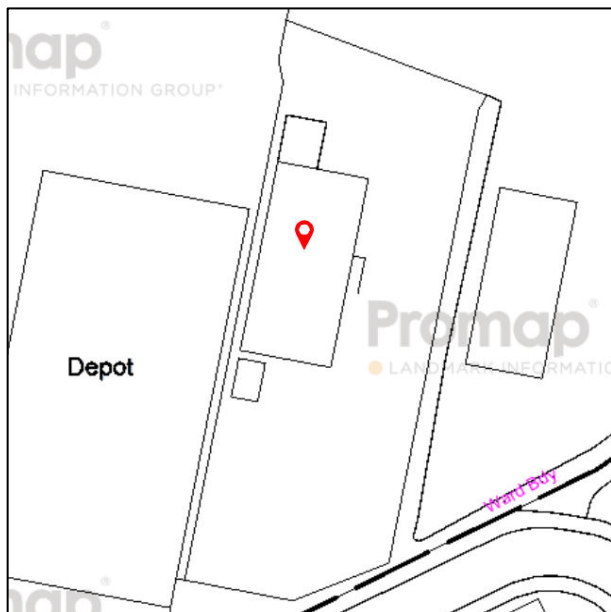
