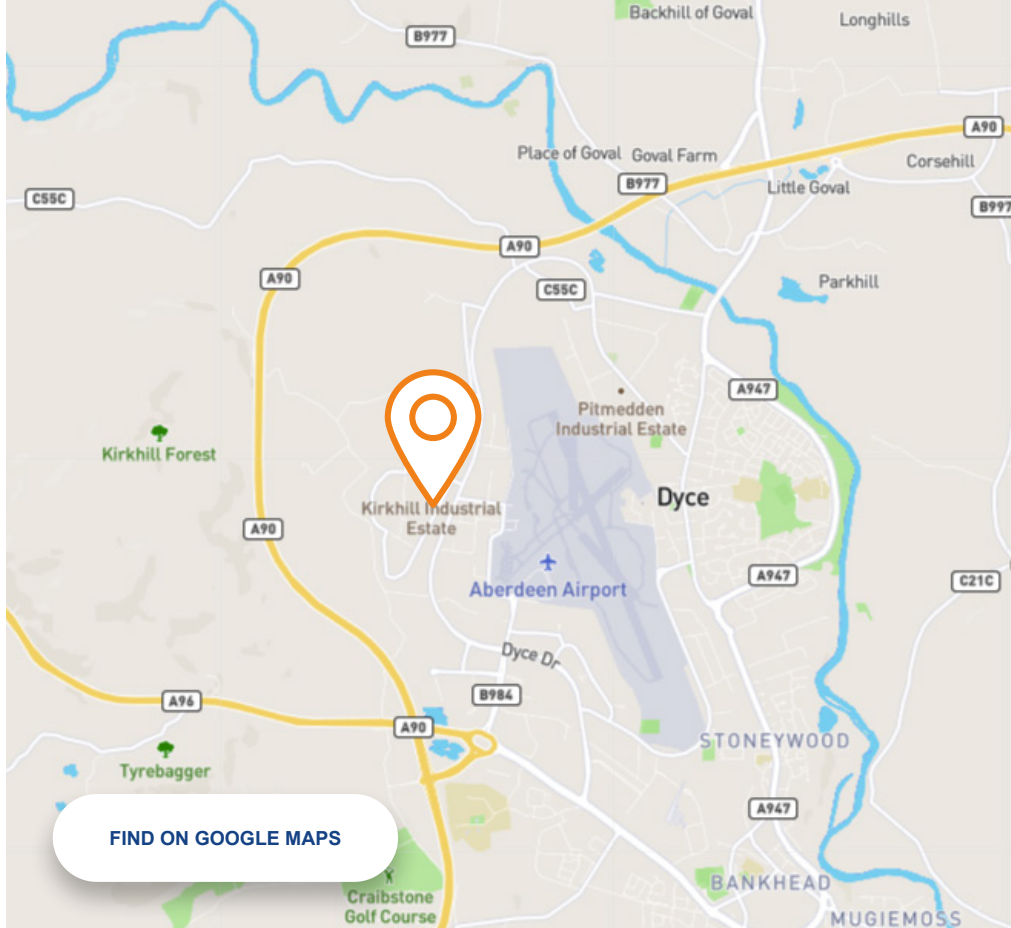

## LOCATION

The subject is located on the east side of Howe Moss Drive within Kirkhill Industrial Estate, approximately 250 metres west of the junction with Howe Moss Road. The property is situated in close proximity to Aberdeen International Airport, lying approximately 6 miles north-west of Aberdeen City Centre.

Nearby occupiers include Independent rope access, Highland oilfield services group, ARR Craib & Kerrs dairy.

## DESCRIPTION

The subjects comprise a terraced industrial unit of steel portal frame construction with blockwork dado and steel pressed sheeting thereafter. The pitched roof incorporates translucent panels. Lighting is by way of high bay sodium fitments. Vehicular access is provided to the unit through an electrically operated metal roller door. The subjects also benefits from 3 phase power supply.

The office accommodation is of plastered blockwork walls and carpeted concrete flooring. Lighting is by fluorescent fitments and natural light through double glazed uPVC windows. Heating is provided by electric panel heaters. Shower facilities are located on the first floor.

The unit is to be refurbished ahead of an ingoing occupiers tenancy. An ingoing occupier would also benefit from use of an exclusive yard area.

Car parking is provided within the communal tarmac surfaced car parking to the front of the unit.

## LEASE TERMS

The accommodation is available on full repairing and insuring terms for a negotiable period. Any medium to long term leases will be subject to upward only rent reviews at regular intervals.

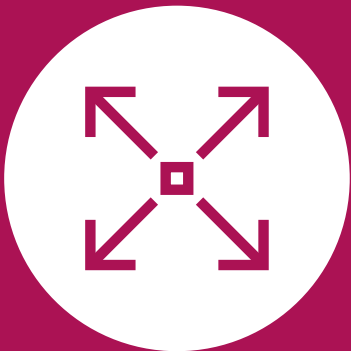
