LOCATION

DESCRIPTION

PARKING

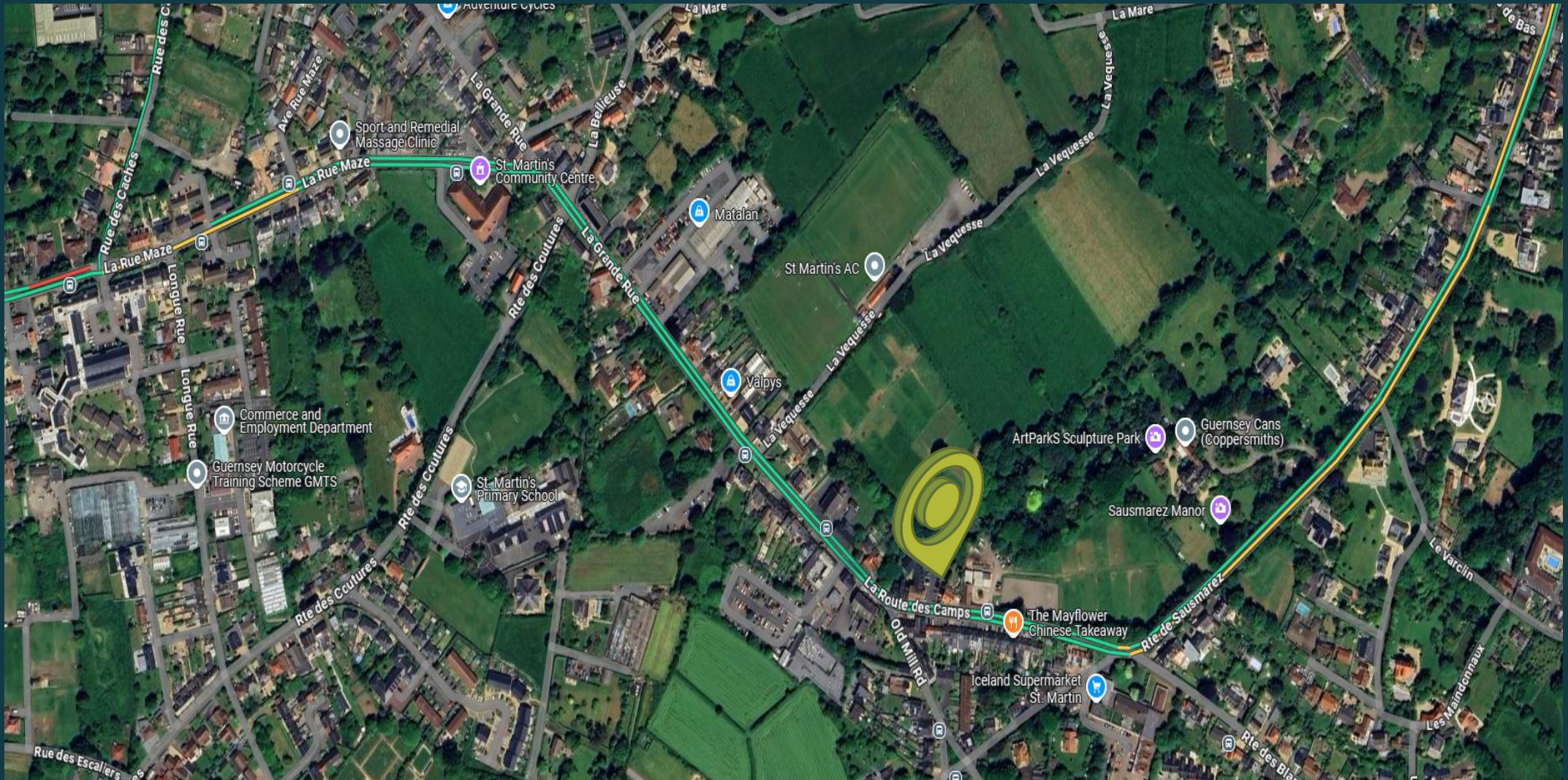
The office has 4 parking spaces 2 of which are blocked. The allocation of spaces is based on 1 space per 510 sq ft occupied.
