Location

Golding Barn Industrial Estate is located within a picturesque setting at the foot of the South Downs National Park. The estate occupies a prominent position on Henfield Road (A2037) in the village of Small Dole, approximately 2 miles south of Henfield. It's location places it within easy reach of several towns including Steyning, Shoreham-by-Sea, Worthing, Brighton, and Horsham, all of which provide business, retail, and leisure amenities.

The estate benefits from excellent connectivity, with direct access to the A23 and A27 corridors. These routes provide convenient links north to Gatwick Airport and London, and south to the South Coast. Rail connections are also within easy reach, with the nearest stations being at Shoreham-by-Sea and Hassocks, both offering regular services to London, Gatwick, and coastal destinations.

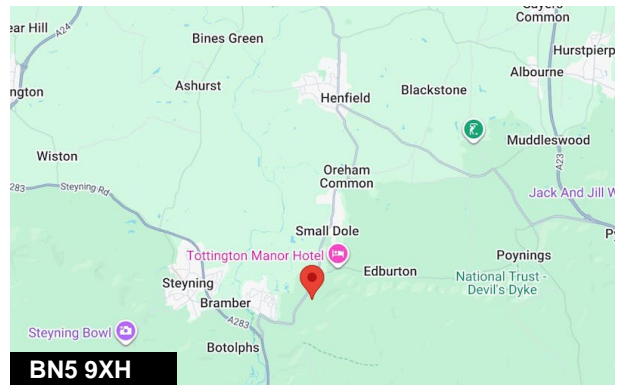
