Location

The property is located near the corner junction of Queensferry Road on the east side of Marischal Place, a continuation of Craigcrook Road between the junctions of Strachan Road and Seaforth Terrace/Queensferry Road.

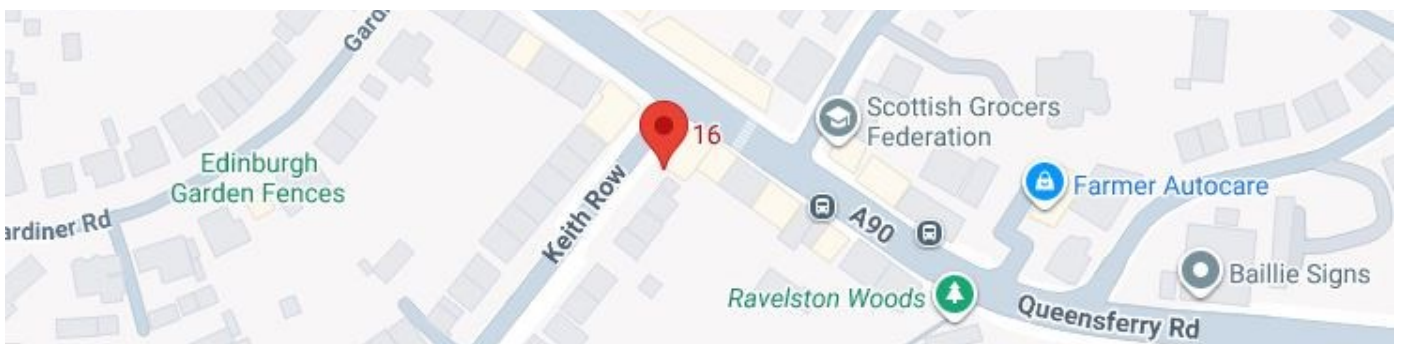
