Planning consent was granted for 67 high-quality new dwellings to be built on the former NHS site creating a sustainable residential development in Fulwood.

The brownfield site is approximately 5.5km from Sheffield city centre to the west. The site currently consists of several commercial buildings, surrounded by driveways, car parking and gardens.

The site is the former location for offices of Sheffield Health Partnership University NHS Foundation Trust. Fulwood Town Centre is a few minutes walk away and has a range of shops and other amenities. The open countryside of the Peak District lies to the West and South West

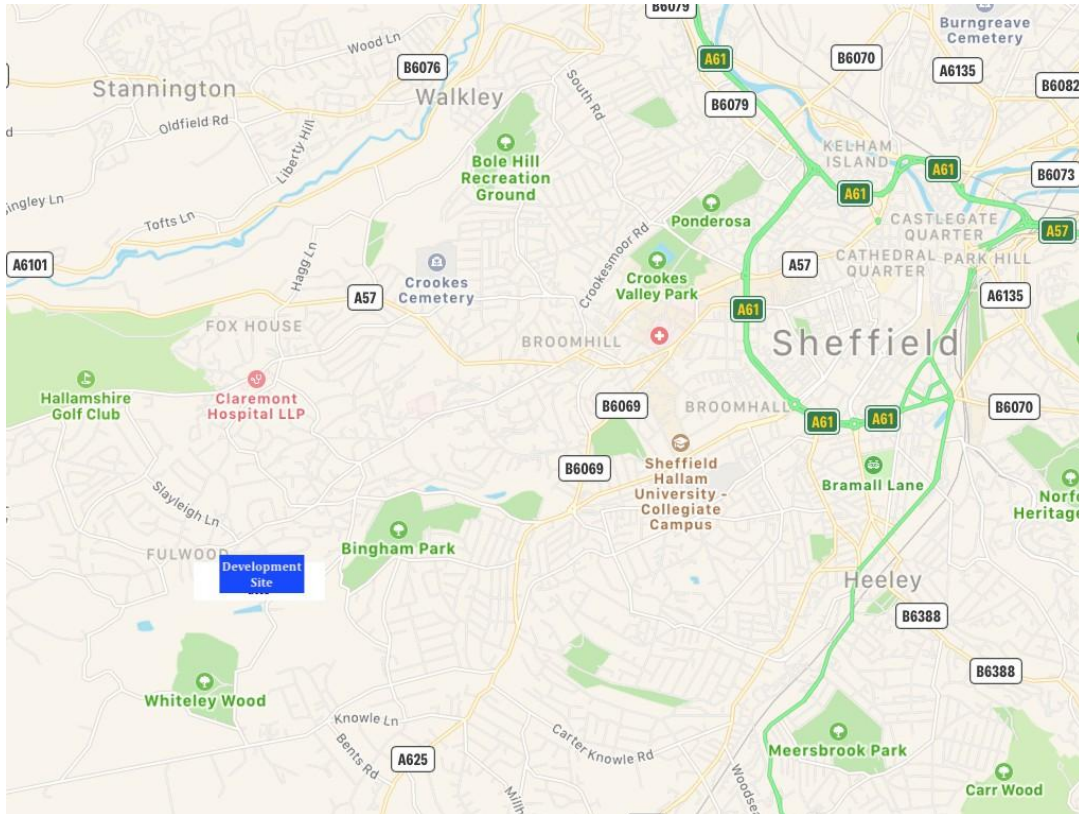
