3 ST JOHN'S SQUARE, THE ROCK SHOPPING CENTRE

LOCATION

The Rock, Bury comprises 620,000 sq ft of retail and leisure space and includes over 1,000 car parking spaces on site. The Rock is anchored by **Marks & Spencer** alongside other retailers including **JD, Footlocker, Lush, Next, River Island, H&M** and **Primark**.

The leisure element of the scheme consists of a **10-screen multiplex Vue cinema** and an **AMF 24 lane bowling**, family entertainment centre. A variety of popular cafes and restaurants include **Racconto Lounge, West Ivy, Frankie & Benny's, Nando's** and **Dunkin Donuts**.

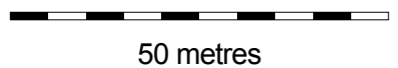
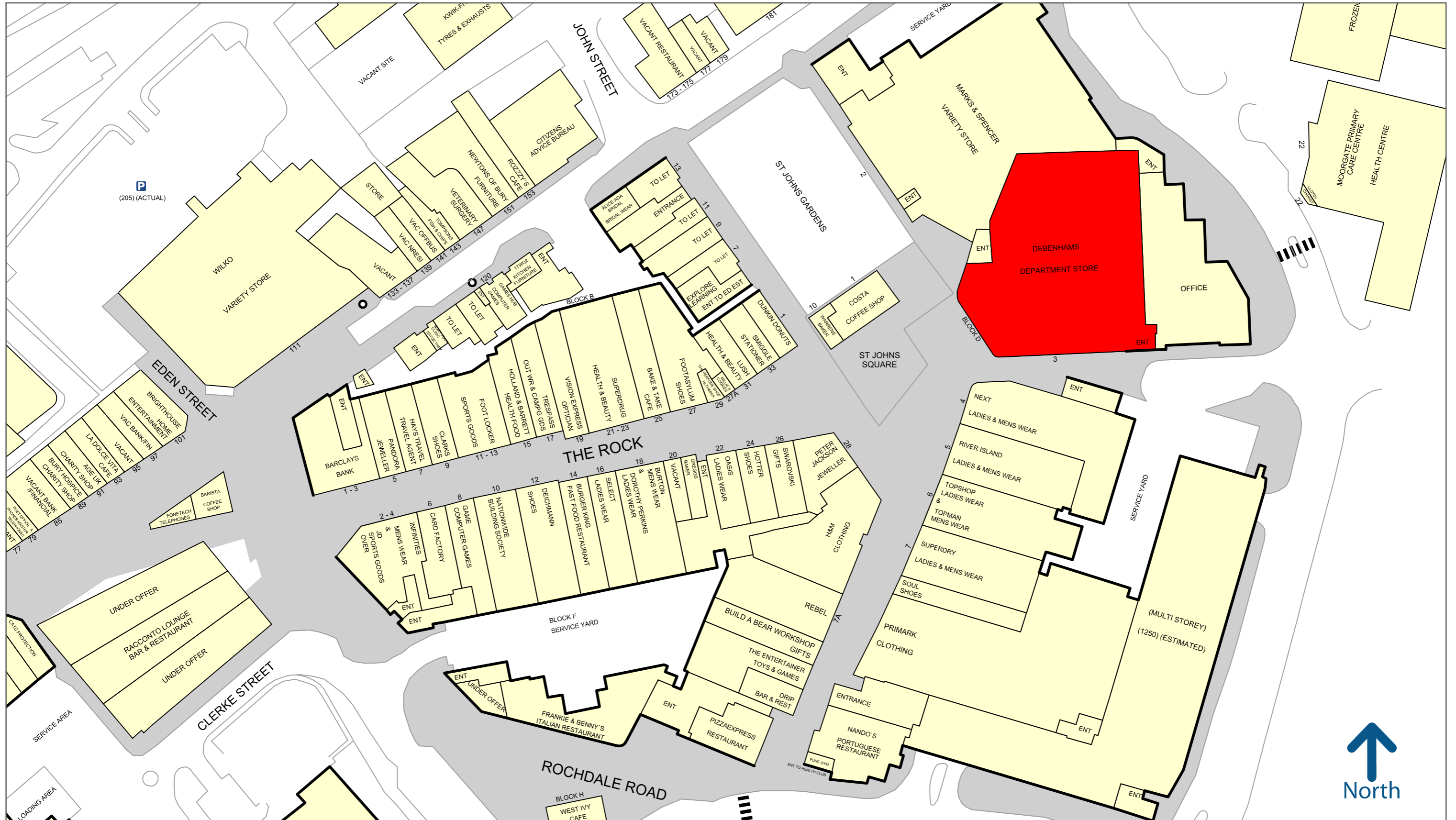
