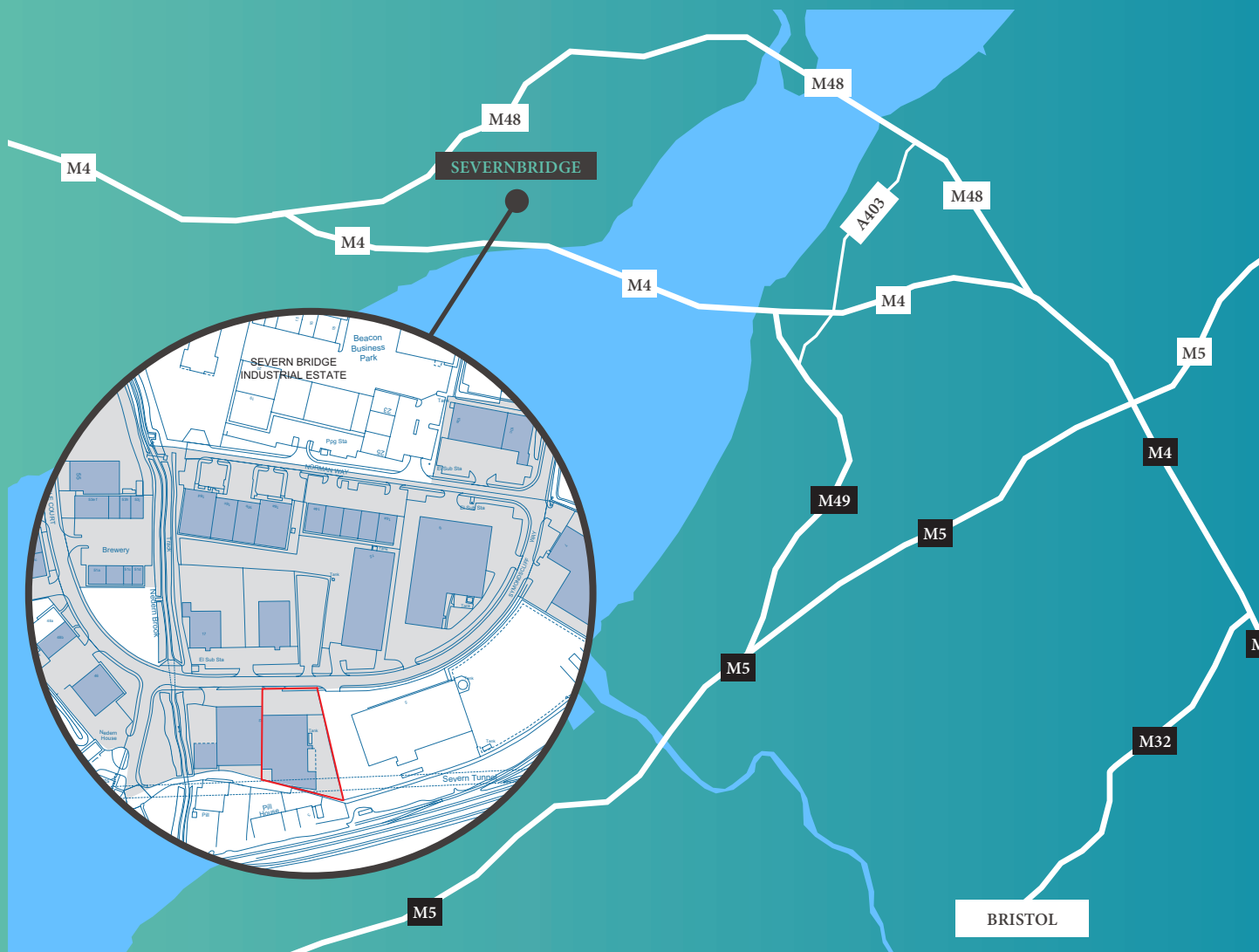

## LOCATION

Caldicot is located in Monmouthshire approximately 5 miles from Chepstow and 13 miles from Newport. The property is located on Symondscliffe Way with nearby occupiers including Hicks Logistics, Evoqua, Keltruck and Pro-Steel Engineering.

Severnbridge Industrial Estate is in close proximity to both the M4 Motorway and the M4/M5 Interchange. Approximate distances and travel times are shown below:

## ACCOMMODATION

**Unit 12A is of steel portal frame construction with brick and profile metal sheet cladding under a pitched roof.** Bespoke office/ancillary accommodation fit out is available and the warehouse currently benefits from kitchen and WC facilities, 3 phase power, concrete flooring and a minimum eaves height of 5.1 metres, maximum eaves height 6.8 metres.

The unit benefits from an internal cold store area. Externally there are parking and loading bays to the front and secure yard areas to the side.

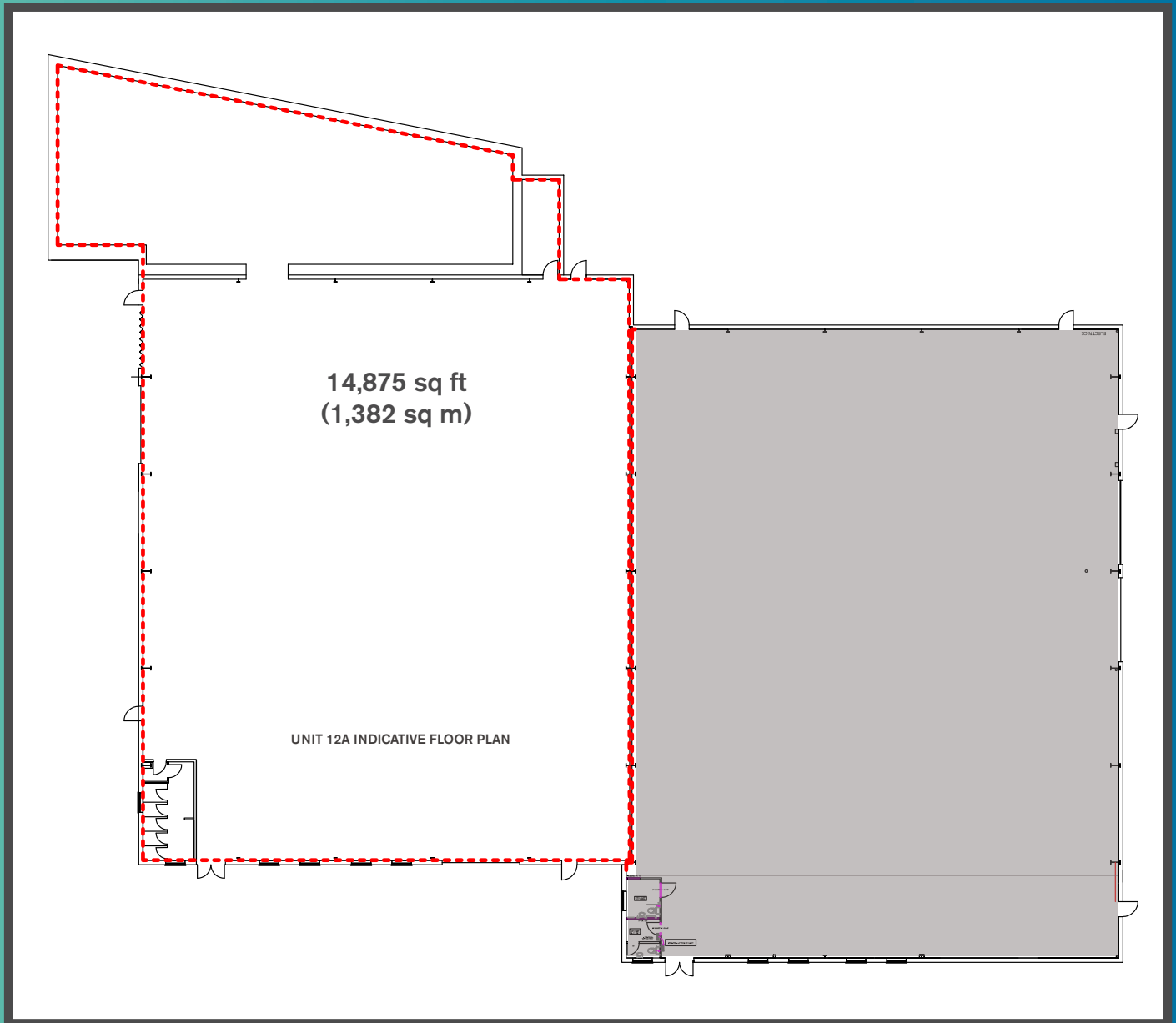
