Corsham is well located on the A4 between Chippenham and Bath. Junction 17 of the M4 is approx. 9 miles away.

## Description

Unit 5 comprises a portal frame building with brick and clad elevations. Commercial vehicle access is gained via a roller shutter entrance door.

Internally the building has been fitted with a part mezzanine floor. Under this is a fitted office, WC and kitchenette facility. Maximum internal eaves height is 5.6m.

Outside, there are 5 allocated parking spaces and a service yard area.

Please note, the adjoining Unit 4 is also available and can be combined with Unit 5.

Unit 4 provides an additional 1,895 sq ft of stores/offices/workshop accommodation.
